Sabirul @ Raju and marked as "Exhibit- A". b) One (01) bottle of "ONEREEX" Cough Syrup (containing 100 ml) randomly taken from "Exhibit- A" for

I, PSI Abhishek Theengh (32), S/O- Sri Suchandra Kumar Theengh of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused person namely Md. Sabirul @ Raju (35) s/o Md. Rafikul of Balijore, PS Itahar, Dist Uttar Dinajpur, A/P Biswas Colony, PS Matigara, Dist Darjeeling to the effect that on 18.08.2021 at about 14:20 hrs I received a specific source input that one person possessing huge quantity of 'Codeine Phosphate' based drugs was standing at West Point School, Tumbajote under Matigara PS to sell the same to his designed local customers. The matter was diarized in Matigara PS GDE No. 992/21 Dt. 18.08.2021 and subsequently, I informed the matter to the Officer-in-Charge, Matigara Police Station in written and being directed, myself along with ASI Nitai Mandal, Const- 1035 Santosh Rabidas, Const- 1008 Kanak Roy and Const- 986 Rajib Sarkar all of Matigara PS, SPC along with investigation kit left for West Point School, Tumbajote under Matigara PS by Govt. vehicle to verify the veracity of the information. This refers to Matigara PS GDE No. 993/21 Dt. 18.08.2021 and M.C.C No-

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to West Point School, Tumbajote under Matigara PS, I contacted two persons namely (1) Pabitra Roy (39) S/O Satyandranath Roy of Tumbajote, P.O+P.S- Matigara, Dist- Darjeeling and (2) Md. Mustafa (24) S/O Abdul Gaffar of Beldangi, P.O+PS- Matigara, Dist- Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with above noted independent witnesses arrived near West Point School, under PS- Matigara at 14.45 hrs and subsequently, being pointed by my source detained 01 (one) person standing near West Point School. He had carried one nylon bag under his possession. Thereafter, we disclosed our identity and the information in hand and stated him that he as well as the bag under his possession will be searched for the purpose. And, I gave him option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which he agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused person to search our Police Party as per provisions but, he did not search the police party. Consequently, I informed the matter to O/C Matigara PS and as per his kind order, I informed to Shri Manish Kumar Yaday, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused person suspected to be possessed 'Codeine Phosphate' based drugs illegally and requested him to come near West Point School, Tumbajote under Matigara PS to remain present and to

Accordingly at 15.25 hrs Shri Manish Kumar Yadav, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC arrived at the spot at near West Commissionerate detailed for acting as Special Executive Magistrate, SPC and in presence of two independent Point School under Matigara PS as Special Executive Magistrate, SPC and in presence of two independent witnesses I searched the detained person following all formalities, keeping his decency and recovered the above noted article from the exclusive and conscious possession of the accused person namely Md. Sabirul @ Raju (35) s/o Md. Rafikul of Balijore, PS Itahar, Dist Uttar Dinajpur, A/P Biswas Colony, PS Matigara, Dist

It has been found from the bag under the possession of the above noted accused person namely Md. Sabirul containing 35 (THIRTY FIVE) bottles of "ONEREEX" cough syrup (each bottle containing 100 ml) containing 35 X 100 ml = 3500 ml i.e., equivalent to 3.5 Kg].

Further, on demand in presence of Shri Manish Kumar Yadav, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC the detained person namely Md. Sabirul @ Raju failed to produce any valid documents/papers or explanation for possessing of such a huge quantity of 'Codeine Phosphate' based drugs beyond the prescribed limit.

Thereafter, I seized the recovered 35 (thirty five) bottles [containing 3500 ml i.e., equivalent to 3.5 Kg] of "ONEREEX" Cough Syrup [including 1 (one) bottles of "ONEREEX" Cough Syrup (containing 100 ml) which were taken randomly from the mother packet for examination] from the exclusive and conscious possession of above noted accused person namely Md. Sabirul @ Raju at the spot at near West Point School under Matigara PS under proper seizure list in presence of independent witnesses and Shri Manish Kumar Yadav, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC obtaining their signature and being acknowledged by the accused person.

Subsequently, I labelled and sealed the seized articles in presence of Shri Manish Kumar Yadav, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC and independent witnesses and the accused persons namely Md. Sabirul @ Raju. The whole process of seizure was made in between 15.35 hrs to 16.10 hrs.

Being further asked, the apprehend person namely Md Sabirul @ Raju admitted in presence of Shri Manish Kumar Yadav, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC and other independent witnesses that he have procured the 'Codeine Phosphate' based drugs clandestinely for the purpose of selling the same in high rate to his designed local customer for his personal gain by illegal means. He also disclosed that he have been dealing in this business of procuring and selling of 'Codeine Phosphate' based drugs illegally for last few months for his wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Md. Sabirul @ Raju is involved in procuring and selling 'Codeine Phosphate' based drugs illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused persons namely Md. Sabirul @ Raju after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Md. Sabirul @ Raju (35) s/o Abwali Md. Rafikul of Balijore, PS Itahar, Dist Uttar Dinajpur, A/P Biswas Colony, PS Matigara, Dist Darjeeling and arrange for its investigation.
