1. I have land situated at Mouza Jhauguri, P.S. Matigara, Dist. Darjeeling and regularly I visit my land.
2. Since 03.08.2021 Mr. Edwin Toppo and his family members started to make attempt to grab my land measuring 10 Decimals, in L.R. Plot No. 355, recorded in my L.R. Khatian No. 1567, within Mouza Jhauguri, J.L. No. 22, P.S. Matigara, Dist. Darjeeling.

3. For this reason on 12.08.2021 I filed one Civil Suit being No. 164/2021 against Mr. Edwin Toppo and his family members and on 12.08.2021 the Ld. Civil Judge, Junior Division has passed a order restraining them from disturbing the Plaintiff possession over the suit land till 18.09.2021 in any manner whatsoever.
4. I have sent the copy of the order alongwith documents and copy of the Plaint and Injunction to the Defendants on 13.08.2021 and all of them have received and have knowledge of the ad-interim order of injunction passed by Ld. Court.
5. By making attempt to make construction for residential house is violation of the Ld. Courts order as such illegal act will amount to disturbing the Plaintiff possession over the suit land.
6. As such I make this complaint before you for taking necessary legal action against Mr. Edwin Toppo and his family members so that they do not do any illegal act which will be violation of the injunction order of the Ld. Court.
