Subject: - Intimation regarding fraudulent report of Covid – 19 RT - PCR

Respected Sir,

My self Sri BARUN ROY, working as Laboratory technician at DUSEN Hospital, Siliguri, Darjeeling, had handed over the nasopharyngeal sample of my father Sri GOBINDO ROY, 59 years to one of my co-employ at Desun Hospital Laboratory, Sri SAIKAT DE for Covid – 19 RT – PCR test. Sri SAIKAT DE (Phone No – 8918643908) assured me that he will get the test done from Apollo Diagnostics Laboratory on 01/05/2021. But after receipt of the said test report on 03/05/2021, while trying to verify the report using its QR code and SRF ID, I found that the report handed over to me was not original. In good faith, apart from my father's sample I had also handed over 3 to 4 others samples to Sri SAIKAT DE for Covid 19 RT – PCR test from Apollo Diagnostic Laboratory which also found fabricated (Report attached).

Since, the incident I am unable to contact Sri SAIKAT DE personally or over phone as he is not attending his duty for last 6 days and his mobile is switched off. Kindly do the needful and oblige.
