Mustata of ari, Netaji Nagar, PS Pradhan Nagar, Dist-Djg along with seized articles view Sir, Campasari, Netaji Nagar, PS Pradhan Nagar, Dist-Djg along with seized articles viz;-1. 10 bottles of Altorex-CD Cough Syrup each bottle containing 100 ml in a white colour carry bag as exhibit-A, ,among which one bottles taken as sample marked as exhibit-A1 respectively. 2. 5 bottles of Maharex Cough Syrup each bottle containing 100 ml in a sky colour carry bag as exhibit-B among which one bottle taken as sample as exhibit-B1, 3. One Scooty displayed Reg. no. WB72L/7110 (pink colour) . The above said Sl. no. 1 &2 kept concealed in this scooty dikky. I beg to report that today on 17.08.21 at about 07:10 hrs received source information that one person named Md. Sakil are selling illegally procured spurious drugs to young youths infront of SNT gate and its adjacent area in a Scooty having Reg. no. WB72L/7110.. Accordingly the matter was diarized in General Dairy vide Pradhannagar PS GDE no- 1038 dated 17.08.21 and informing your end, without making any delay I SI. Haen Mohanta along with ASI.Ratan Pradhan C.V/128 Ajay Kr Sahani, CV/223 Swapan Chettri, CV 992 Jagadish Biswas all of Pradhannagar PS rushed to the spot near SNT Gate, Pradhannagar VIDE Pradhan Nagar Ps GDE No. 1039 dt. 17.08.21 at 07:15hrs. On way requested two disinterested person namely (1) Dinesh Mahato s/o Lt Randaw Mahato of Samarnagar, Battla, , PS Pradhannagar, Dist. Darjeeling and (2) Mohan Mahato S/O R..Mahato of 'DO' to stand as a witness to the search and seizure if any. At about 07:25 hrs reached the place near SNT Gate, Pradhannagar contacted with the source and keeping the vehicle at a distance started on foot. As pointed by the source in presence of the witnesses apprehended one male person riding in the above said scooty. We disclosed our identity as police personnel. Then said person started trembling in panic. On being asked the person disclosed his identity as noted above. Then disclosing our presence and following all formalities conducted search person and his dikky noticed two above said carry bags and opening those carry bags, the above noted cough syrup /drugs could be recovered.

On being asked the person in respect of such possession, he stated different statement at different times, which arouse suspicion that he has procured the same illegally for its clandestine disposal. Further, he also could not produce any papers in support of such possession of syrups. On further interrogation the apprehended person stated that he is selling illegal drugs at that locality for his wrongful gain.

Accordingly, I prepared seizure list and seized the above noted articles, labeled it duly signed by the witnesses and acknowledge by the accused person and witnesses and arrested the accused person namely (i) Md. Sakil (24) S/O Md. Mustafa of Campasari, Netaji Nagar, PS Pradhan Nagar, Dist-Dig u/s 41 CrPC. The seizure and arrest made in between 07:45hrs hrs to 08:15hrs hrs.

Under the above, I pray before your kind end to start a case against the arrested person namely (i) Md. Sakil (24) S/O Md. Mustafa of Campasari, Netaji Nagar, PS Pradhan Nagar, Dist-Djg under proper section of law and caused its investigation.
