Sir,

In producing herewith one accused person namely Prakash Rai-60yrs s/o Lt Pantuman Rai of Kamalanagar, PO Salugara, Ward No-42, PS Bhaktinagar Dist Jalpaiguri along with the following seized articles as per proper seizure list:

1. 10 (Ten) pouch packets of Officers choice deluxe Whisky each bottle containing 180 ML
2. 24 (Twenty four) Bottles of TUBORG strong premium Beer (each packet containing 330ML)

All the articles packed in one big nylon bag.

I beg to report that I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one Prakash Rai-60yrs s/o Lt Pantuman Rai of Kamalanagar, PO Salugara, Ward No-42, PS Bhaktinagar Dist Jalpaiguri to the effect that on 18.08.21 at 14.05 hrs while myself along with force performing PS mobile duty received a source information from Kamalanagar under Bhaktinagar PS that one person namely Prakash Rai of that locality gathered huge quantity of liquor in his house for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-1009 dated 18.08.21. As per your kind instruction myself along with force proceeded to the PO to work out the information. At 14.45 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities. (The seizure was made in between 14.55hrs to 15.20 hrs)

I therefore request you a specific case may kindly be started against the accused person namely Prakash Rai-60yrs s/o Lt Pantuman Rai of Kamalanagar, PO Salugara, Ward No-42, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
