It took place on yesterday. Today again said Sambhu Dey denied me to provide ration and again I protested at that very moment said Sambhu Dey threatened me for their consequences. Today at about 6.45pm when I was entering into my residence suddenly one said Sambhu Dey ,his son Kaushik Dey and another person namely Gautam Dey who runs an illegal shop of explosive and petrol came in front of me and assaulted me by fisting at my face . They also tried to molest me by touching my private parts and they also tried to tear my clothes and tried to rape me .I tried my level best to protect myself but I fell dawn as result I got injury at my legs ,I also got injury on my left hand .I shouted loudly and some passerby and strangers came and those wrong doers and ran away from the spot ,therefore I am requesting you to protect my life, and my dignity and punish the above named wrong doers as per the provisions of law.
