presently attached with NJP PS under your kind control beg to state that today i.e. on 21.08.21 at 14.25 hrs I received a secret source information that one person namely Sujan Sarkar of Baribhasa, Madani Bazar, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his shop at Madani Bazar, PS- NJP, Dist.- Jalpaiguri for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 1066 dated 21.08.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Khagen Barman, C/1053 Paresh Rava, CV/824 Niru Yadav all of NJP PS, SPC left for Madani Bazar to work out the information in hand. At about 14.55 hrs we arrived at the shop of accused Sujan Sarkar of Madani Bazar, PS- NJP, Dist.- Jalpaiguri and being shown and identified by the source we held raid at his shop and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his wrongful gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any in respect of store/sale the I/D liquor found at his shop. Accordingly, 1 seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between 15.15 hrs to 16.05 hrs on 21.08.21.
