In producing herewith arrested accused person namely Pravans Sahani (63) S/O Late Gango Sahani Of Tikiapara, Matangini-II, Ward No. 28, PS- Siliguri, Dist- Darjeeling along with seized articles vize- i) 23 (Twenty three) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 23 x Rs 100/- =RS.2300/-) as per seizure list.

I, ASI Siben Sarkar of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person Pravans Sahani (63) S/O Late Gango Sahani Of Tikiapara, Matangini-II, PS- Siliguri, Dist- Darjeeling to the effect that on 21.08.21 at 08.35 hrs acting on secret information, I received a source information that the above noted person was busy to sale ld liquor illegally in his house situated at Tikiapara, Matangini-II, Ward No. 28 under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 1266 dated 21.08.21 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with ASI Dhruba Mishra & CV/622 Ramanath Barman left for Tikiapara, Matangini-II, Ward No. 28 under Siliguri PS to verify the veracity of the information vide Siliguri PS GDE No. 1267 dated 21.08.21. On reaching at 08.45 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person and on interrogation, the above noted person disclosed his identity as noted above. On searching - i) 23 (Twenty three) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100

each (Amounting of 23 x Rs 100/- =RS.2300/-) which was kept concealed in his house situated at Tikiapara Matangini-II. On being interrogation he could not produce any valid documents in respect of the said liquor. He also stated that he is doing this liquor business since long for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 08.55 hrs to 09.55 hrs. On being asked he stated that he used to sale the same to locality without any valid documents as he has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. As such I arrested her U/S-41 Cr.P.C after observing all sorts' of rules.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person Pravans Sahani (63) S/O Late Gango Sahani Of Tikiapara, Matangini-II, PS- Siliguri ,Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigate.
