In producing herewith two (02) arrested accused persons namely Md. Safikul (25) s/o Md Alam, of Biswas Colony, PO+PS Matigara, Dist Darjeeling. 2. Md. Samsher (19) s/o Md. Taiyab of Simrai Bazar near St. Anthony School, PO Ragupur, Dist-Supul/Bihar A/P- C/O Md Alam of Biswas Colony, PO+PS Matigara, Dist Darjeeling, with the following articles under proper seizure as per-seizure list;

a) One black and red coloured school bag styled as 'SKYBAGS' containing 40 (Forty) bottles of "PHENSEDYL" Cough Syrup (each bottle containing 100 ml) having Batch No. PHB 21037, Mfg. Date: 03/2021. Exp. Date: 08/2022 seized from the possession of above noted Md. Safikul and marked as "Exhibit-A".

b) One (01) bottle of "PHENSEDYL" Cough Syrup (containing 100 ml) randomly taken from "Exhibit- A" for

c) One black coloured school bag styled as 'STAR FANCY BAG' containing 22 (Twenty Two) bottles of "LYKAREX" Cough Syrup (each bottle containing 100 ml) having Batch No. TBHU0272, Mfg. Date: 02/2021. Exp. Date: 01/2023 seized from the possession of above noted Md. Samsher and marked as "Exhibit-B". d) One (01) bottle of "LYKAREX" Cough Syrup (containing 100 ml) randomly taken from "Exhibit-B" for examination and marked as "Exhibit B-1".

I, PSI Abhishek Theengh (32), S/O- Sri Suchandra Kumar Theengh of Matigara PS, SPC do hereby lodged this written complaint against the above noted accused persons namely Md. Safikul (25) s/o Md Alam, of Biswas Colony, PO+PS Matigara, Dist Darjeeling. 2. Md. Samsher (19) s/o Md. Taiyab of Simrai Bazar near St. Anthony School, PO Ragupur, Dist-Supul/Bihar A/P- C/O Md Alam of Biswas Colony, PO+PS Matigara, Dist Darjeeling under Matigara PS to the effect that on 23.08.2021 at about 09:15 hrs I received a specific source input that two persons possessing huge quantity of 'Codeine Phosphate' based drugs was standing at Old Matigara Road, near Chamta Bridge under Matigara PS to sell the same to their designed local customers. The matter was diarized in Matigara PS GDE No. 1249/21 Dt. 23.08.2021 and subsequently, I informed the matter to the OC, Matigara PS in written and being directed, myself along with ASI Nitai Mandal, Const- 1035 Santosh Rabidas, Const- 1008 In written and being directed, mysen along with ASI Nital Mandal, Collect Took Saltosh Matigara PS, SPC along with Kanak Roy, Const- 986 Rajib Sarkar and CV/387 Sukumar Barman, all of Matigara PS, SPC along with investigation kit left for Old Matigara Road, near Chamta Bridge under Matigara PS by Govt. vehicle to verify the veracity of the information. This refers to Matigara PS GDE No. 1250/21 and M.C.C No- 54/021 Dt- 23.08.2021.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to Old Matigara Road under Matigara PS, I contacted two persons namely (1) Md. Azad Ali s/o Md. Mehbub Ali and (2) Md. Jamil Akhtar s/o Md. Muslim both of Tumbajote, PO+PS Matigara, Dist Darejeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with above noted independent witnesses arrived Old Matigara Road, at 09.45 hrs and subsequently, being pointed by my source detained 02 (two) persons standing at Old Matigara Road near Chamta Bridge. They had carried two school bags as noted above under their possession. Thereafter, we disclosed our identity and the information in hand and stated them that they as well as the bags under their possession will be searched for the purpose. And, I gave them option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which they agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused persons to search our Police Party as per provisions but, they did not search the police party. Consequently, I informed the matter to O/C Matigara PS and as per his kind order, I informed to Shri Pasang Topgay Bhutia, ACP, SPC detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused persons suspected to be possessed 'Codeine Phosphate' based drugs illegally and requested him to come at Old Matigara Road, near Chamta Bridge to remain present and to supervise the search and seizure.

Accordingly at 11.05 hrs Shri Pasang Topgay Bhutia, ACP, SPC detailed for acting as Special Executive Magistrate of SPC arrived at the spot at Old Matigara Road'as Special Executive Magistrate, SPC and in presence of two independent witnesses I searched the detained persons following all formalities, keeping their decency and recovered the above noted article from the exclusive and conscious possession of the accused persons namely Md. Safikul and Md. Samsher.

It has been found from the bag under the possession of the above noted accused persons namely Md. and Md. Samsher containing A] 40 (Forty) bottles of "PHENSEDYL" cough syrup (each bottle containing containing 40 X 100 ml = 4000 ml i.e., equivalent to 4 Kg, B] 22 (twenty two) bottles of "LYKAREX" cough (each bottle containing 100 ml) containing 22 X 100 ml = 2200 ml i.e., equivalent to 2.2 Kg. Total of 62 bo Codeine Phophate (each bottle containing 100 ml each) containing 62 X 100 ml = 6200 ml, i.e, equivalent kg.

Further, on demand in presence of Shri Pasang Topgay Bhutia, ACP, SPC detailed for acting as S Executive Magistrate of SPC the detained persons namely Md. Safikul and Md. Samsher failed to produvalid documents/papers or explanation for possessing of such a huge quantity of 'Codeine Phosphate' drugs beyond the prescribed limit.

Thereafter, I seized the recovered AJ 40 (Forty) bottles of "PHENSEDYL" Cough Syrup [including 1 bottles of "PHENSEDYL" Cough Syrup which were taken randomly from the mother packet for examinati 22 (twenty two) bottles of "LYKAREX" Cough Syrup [including 1 (one) bottles of "LYKAREX" Cough Syrup were taken randomly from the mother packet for examination] from the exclusive and conscious possess above noted accused persons namely Md. Safikul and Md. Samsher at the spot at Old Matigara Road, Chamta Bridge under proper seizure list in presence of independent witnesses and Shri Pasang Topgay BI ACP, SPC detailed for acting as Special Executive Magistrate, SPC obtaining their signature and acknowledged by the accused persons.

Subsequently, I labelled and sealed the seized articles in presence of Shri Pasang Topgay Bhutia, ACP, detailed for acting as Special Executive Magistrate, SPC and independent witnesses and the accused per namely Md. Safikul and Md. Samsher. The whole process of seizure was made in between 11.15 hrs to 1 hrs.

Being further asked, the apprehend persons namely Md. Safikul and Md. Samsher admitted in present Shri Pasang Topgay Bhutia, ACP, SPC and other independent witnesses that they have procured the 'Cod Phosphate' based drugs clandestinely for the purpose of selling the same in high rate to their designed I customer for their personal gain by illegal means. They also disclosed that they have been dealing in business of procuring and selling of 'Codeine Phosphate' based drugs illegally for last few months for twrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused pers namely Md. Safikul and Md. Samsher is involved in procuring and selling 'Codeine Phosphate' based drillegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused persons namely Md. Safikul and Md. Samsher after observing formalities and informing the ground of their arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly started against the accused persons namely Md. Safikul (25) s/o Md Alam,of Biswas Colony, PO+PS Matiga Dist Darjeeling. 2. Md. Samsher (19) s/o Md. Taiyab of Simrai Bazar near St. Anthony School, PO Ragup Dist-Supul/Bihar A/P- C/O Md Alam of Biswas Colony, PO+PS Matigara, Dist Darjeeling under Matigara PS a arrange for its investigation.
