I, SI Kalipada Barman of Matigara PS SPC to the effect that on 24.08.2021 while performing SPL Mobile duty under Matigara PS area found Four persons namely (i) Santosh Sah (30), S/O Lal babu Sah of Gaddarpur, PS - Parod, Dist - Mujaffarpur, Bihar, (ii) Shekhar Suman (32), S/O Lalan Kumar Pandey of Muza Banjra, PS - Dewaiya, Dist - Mujaffarpur, Bihar, (iii) Md. Bechu Singh of Lake garden, PS - Lake Garden, Dist - South 24 Pargana under proper section of law and arrange for its investigation.
