I Baljit Singh S/O Shri Balbir Singh R/O 54 Feet Road Second Street, Near Vidya Nagar, Bhiwani, Haryana, Presently Residing at Punjabi Para, Ward no.13 within S.M.C.P.O-Siliguri, P.S-Siliguri, Dist-Darjeeling would like to bring this into your kind notice that I am an employee of 'SONA OXYGEN PRIVATE LIMITED's ituated at Plot no.37, Dabgram Industrial Estate, P.O-Satelite Township, P.S-New Jalpaiguri, Dist-Jalpaiguri.

That on the eve of 20/08/2021 at around 7.30 PM when I was returning home after having visited the Eastern Bypass for discharge of my duties, a group of five people surrounded me near the dump yard of which one was Praveen Malhaan whom I recognised as he too was an employee/Manager of "SONA OXYGEN PRIVATE LIMITED" who had earlier resigned after the Directors came to know about the irregularities in finance and working.

I request your esteemed office to take strong and detterent action against these miscreants and book them against relevant penal sections as per the law of the land.
