Deoghar (ii) Panesh Roy (32) S/o Lt. Bhola Roy of Telipara, Salkhowajhora, PS Bhaktinagar, Dist. Jalpaiguri (iii) Pappu Alam (27) S/o Maksud Alam of Ashraf Nagar, Near Masjid, PS Bhaktinagar, Dist. Jalpaiguri (iv) Sourav Paul (31) S/o Krishna Paul of Pradhan more, Near Ieson mandir, PS Bhaktinagar, Dist. Jalpaiguri (v) Md. Jawed (35) S/o Md. Idrish of Durga Nagar, Near mobile tower, PS Bhaktinagar, Dist. Jalpaiguri arrested u/s 41 Cr.P.C..

I, SI Kamal Kumar Sarkar of Bhaktinagar PS, SPC do hereby lodge complaint against the above noted persons, to the effect that 24.08.2021 between 17.05 hrs to 19.25 Hrs, I along with officer and force were performing lock down patrolling duty in c/w COVID-19 at Salugara Bazar, under Bhaktinagar PS, Dist-Jalpaiguri. At around 18.55 hrs during my patrolling duty found the above noted persons were moving without any mask and without any reason. Thereby making unnecessary gathering. On being asked the above noted persons stated that they were well aware of lock down and pandemic Covid-19 situation and they supposed to wear face mask. Further I requested them to wear Mask and maintain the social distance but they did not pay any heed. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of Pandemic COVID- 19 throughout the Country. Finding no any other alternative I arrested them u/s 41 Cr.P.C under proper memo of arrest after explaining the charge against them.

Under the above circumstance I request you that a specific case may kindly be started U/S 188/269/270 IPC R/W Sec 51(b) Disaster Management Act, 2005 against the above noted 05 (Five) arrested accused persons and arranged proper investigation of the case.
