- (1) One transparent plastic packet which contains 100 grams seems to be "Brown Sugar" which was kept concealed in shirt pocket of the accused Jiaul Sekh (40) s/o-Dulu Sekh of Chaipara,PO-Jainpur PS-Boishnab Nagar Dist-Maldah and marked as Exhibit 'A' and out of which 06.00 Grams seems to be "Brown Sugar" taken as sample marked as Exhibit -"A-1"
- (2) One mobile phone Samsung DUOS having IMEI no-359311102535992 and
- (3) Total cash Rs-15500/-(Fifteen Thousand and five hundred only)

I SI Biswajit Ghosh of Detective Department, Siliguri police Commissionerate lodge a written complaint to the effect that on 27.08.21 at about 17.35 hrs received reliable source information that one person was standing near Jhatiakhali more under NJP PS area. He possessed the Illegal narcotic substances and ready for selling the same to the designed customers for his wrongful gain. Accordingly, the matter was diarized vide Detective Department, SPC GDE No.132 Dt- 27.08.21. Accordingly informed to the ACP DD /SPC.

At about 17.45 hrs as per direction myself along with ASI Proloy Bhattacharjee, C/682 SK Sabrati,C/1054 Arobindu Roy, C/371 Sushanta Dey all of Detective Department, Siliguri Police Commissionerate left for Jhatiakhali more under NJP PS area to verify the authenticity of the information. This refers to D.D SPC C.C. No 256/21 Dt. 27.08.21 which refers to D.D, SPC GDE No. 133 dated 27.08.21. At the time of departure from the office, I took envelope, white paper, sealing wax, gum, seal, official stamp, stamp pad and all necessary requirements.

At 18.15 hrs we reached at near Jhatiakhali more under NJP PS area and sometimes after, being identified by the source we found that one young male person was standing at Near Jhatiakhali more under NJP PS area and found his suspicious motive.

Thereafter without any further delay, we quickly tried to detain the said young male person with strong reason to believe that the said person was illegally possessing narcotic substances. However we apprehended the said person. After disclosing our identity and disclosed him the reason of suspicion for detaining him, he disclosed his name and address as Jiaul Sekh (40) s/o-Dulu Sekh of Chaipara, PO-Jainpur PS-Boishnab Nagar Dist-Maldah.

Then I asked the detained alleged person whether he wanted to be searched in presence of Executive Magistrate or Gazetted Officer and he agreed to be searched by any one. Then, I served him a notice in accordance with provisions of law and I also offered him to search the Police Party as per provision.

Then I informed to Sri Rajen Chettri,ACP,DD as Special Executive Magistrate, Siliguri Police Commissionerate over phone regarding the interception of the accused person suspected to be possessing the consignment of narcotic substances and requested him to come at Near Jhatiakhali more under NJP PS to supervise during seargh and seizure as per provision
