Pradhannagar Police Station, SPC would like to lodge a writing Commissionerate leep Sriwastav(31) S/O Lt. Dinesh Kumar Sriwastav of WNo 5 Commissionerate (1) Sandeep Sriwastav(31) S/O Lt. Dinesh Kumar Sriwastav of W/No.5,Ganga Nagar,Gali no.2,Ps.Siliguri.Dist-Darjeeling ,(2) Bhola Mahato(41) S/O Kishor Mahato of Santoshi Nagar near Bishnu Mandir,W/No.5,PS.Siliguri. Dist-Darjeeling(Driver of Piaggio) also would like to produce before you following seized articles as per seizure

- 10(ten) big Cartons each carton contains 48 (forty eight ) bundles of H-10 Cigarettes, each bundle i) containing 25(twenty five) no.s of small packets each packet contains 10 pieces of H-10 Cigarettes total 1,20,000 (one lakh twenty thousand only) pieces H-10 Cigarettes. ii)
- One Piaggio having reg. no. WB 73 X 2329 in which the above noted articles were loaded.

The brief fact is that on 27.08.21 at about 07:00 hrs myself received a secret source information that one Piaggio having registration no. WB 73 X 2329 boarded driver & other one loaded with huge quantities of H-10 cigarettes packets does not contains manufacturing date, expiry date, Bar Code, company name, M.R.P. no any birl or valid documents which will be reached very soon in Siliguri from Bihar side . I diarized the information vide Pradhan Nagar P.S General diary vide GDE No. 1762 Dt. 27.08.2021 and informed the tip off information to you for kind instruction. On being directed, myself along with PSI. Kalyan Saha, ASI. Debasish Das, ASI Ratan Pradhan, ASI Ashit Kr Singh, CV 646 Baban Das, CV/645 Pankaj Gupta left P.S at 07:10hrs vide PDN PS GDE No.1763 dtd. for perusing the information.

We reached at Gurung busty more near Mahananda Bridge under Pradhan Nagar P.S. at about 07:15 hrs. Thereafter we started waiting, after a while at 07:50hrs the source pointed towards a Piaggio vehicle having reg. ..o. WB 73  $\lambda$ 2329 in which the above noted articles are loaded we gave signal to be stopped but the vehicle was trying to fled away. However we apprehended the Piaggio vehicle & cordoned from all sides to avoid any chance of the driver escape. Thereafter we disclosed our identity and the information in hand and asked about the owner of loaded articles where the boarded person stated that he is the owner of loaded goods .I stated him that he will be searched in person for the purpose. On being asked the person failed to produce any the challan in r/o loaded goods. There was strong reason to believe that the article is very much suspicious. Thereafter, we searched the loaded goods and recovered above said H-10 Cigarettes packets does not contains manufacturing date, Expiry Date, Bar Code, company name, M.R.P. The above said person failed to produce any documents in r/o such huge quantities of

Accordingly, I have seized above recovered H-10 Cigarettes total 1,20,000 pieces H-10 Cigarettes inbetween 07:55 hrs to 09:05 hrs by preparing a seizure list & labeled duly signed by the accused person and witnesses and arrested the above said both accused person. On interrogation both person stated that he procured the same from Bihar side and selling illegally at Siliguri area to obtain huge profit. Then we returned back to PS. taking the accused & seized article.

In the above circumstance, I pray before you to take charge the seized articles and also to start a specific case against (1) Sandeep Sriwastav(31) S/O Lt. Dinesh Kumar Sriwastav of W/No.5,Ganga Nagar,Gali no.2,Ps.Siliguri,Dist-Darjeeling ,(2) Bhola Mahato(41) S/O Kishor Mahato of Santoshi Nagar near Bishnu Mandir, W/No.5, PS. Siliguri, Dist-Darjeeling (Driver of Piaggio) and others under proper section of law and arrange for investigation.
