ne Officer In-Charge, Matigara Police Station, Siliguri Police Commissionerate Sub: - FIR In producing herewith two (02) arrested accused persons namely 1) Sanket Misra (26), S/O-Shibananda Misra of Ghorapith lake garden, PO- Rathbari, PS- Englishbazar, Dist- Malda and 2) Bapi Sharma (28), S/O- Robi Sharma of Bagdogra Masjitpara, PO+PS- Bagdogra, Dist- Darjeeling (not verified) along with the following seized article under proper seizure as per seizure list; a) One transparent plastic packet containing 190 grams of brown sugar which was kept inside the under- seat storage of one White colour Activa Scooty having registration number WB74W 3535, and marked as "Exhibit- A". b) One transparent pouch containing 20 grams brown sugar taken as sample from exhibit "A" for examination and marked as Exhibit "A-1". c) One Redmi note 9 pro Mobile having IMEI No.869009043850 and 8690090438500739 including one SIM having connection No.8327096026 found from the left side pocket of trouser of Sanket Misra and market as "Exhibit-B" d) One White colour Activa Scooty having registration number WB74W 3535, Engine No. JC44E1612265 and Chassis No. ME4JC448JB8501220 and marked as "Exhibit-C" e) One piece of paper having calculation (Supposed to be of Brown sugar and its price noted against the name of various customers) from the date 21.08.021 to 27.08.2021 found from the right side pocket of trouser of Sanket Misra. f) Cash rupees 1,35,000/- [Rupees one lakh and thirty-five thousand] only in Indian Currency Note in the following denomination; Rs. 2000 X 2 = 4,000, Rs. 500 X 192 = 96,000/-, Rs. 200 X 82 = 16,400/-, Rs. 100 X 186 = 18,600/-, Rs. [Total = 1,35,000/- (Rupees one lakh and thirty-five thousand) only. [Kept into the under- seat storage of SL. No - d] I, SI Shekhar Adhikary, S/O- Lt. Sonatan Adhikary of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused persons namely Sanket Misra and Bapi Sharma (not verified) to the effect that today on 29.08.2021 at about 12.25hrs I received a specific source input that two persons were standing at Phansidewa more under Matigara PS with huge quantity of Brown Sugar for delivering the same to their designed customers at the adjacent areas. The matter was diarized in Matigara PS GDE No. 1602, Dt-29.08.2021 and subsequently, I informed the matter to the Officer-in-Charge, Matigara Police Station in written and being directed, myself along with ASI Binod Jha, ASI Rash Bihari Saha both of SOG, SPC and ASI Nitai Mandal, ASI Tapan Das, Const- 1008 Kanak Roy, Const- 986 Rajib Sarkar, CV-155 Sukumar Das and CV-387 Sukumar Barman all of Matigara PS, SPC along with investigation kit left for Phansidewa more under Matigara PS by govt. vehicle to verify the veracity of the information. This refers to Matigara PS GDE No. 1603, Dt- 29.08.2021 and M.C.C No- 2216/21 Date- 29.08.2021. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. On way to Phansidewa more, I contacted two persons namely 1) Md. Khalilur Rahaman, S/O-Lt. Md. Hachan Ali of Tarijote, PO- New Rongia, PS- Matigara, Dist- Darjeeling and 2) Jitendra Barman (32), S/O- Lt. Lalit Barman of Rananagar Clony, PO+PS-Matigara, Dist- Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter we along with the independent witnesses noted above reached at Phansidewa more under Matigara PS at 12.50hrs and being pointed by my reliable source approached towards two persons standing there with a white coloured Scooty. At that time seeing the Police party approaching towards them they started fled away from the spot riding the Scooty but, however we managed to apprehend them with the Scooty. Above noted Sanket Misra was found riding the above noted Scooty and above noted Bapi sharma was found as pillion rider on the above note Scooty. Thereafter, we disclosed our identity and the information in hand and stated them that they will be searched in person for the purpose. At this, they after disclosing their identity as noted above admitted that they have illegally possessed brown sugar for selling the same to their designed customers as per their requirement. I then gave them option in writing whether they wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer.
