In producing herewith the three arrested accused persons namely 1. Netai Saha (57) s/o-Lt Dinesh Ch Saha of Hakimpara, Near Dudh more, W/N-15 PS-Siliguri Dist-Darjeeling 2. Partha Saha (42) s/o-Lt Shasti Saha of Sanghoti more, w/n-38 PS-Bhaktinagar Dist-Jalpaiguri 3. Subal Das (54) s/o-Lt Radhanath Das of Baghajatin Colony, road no-2/5, w/n-02 PS-Pradhannagar Dist-Darjeeling along with seized articles viz

i) One white colour Bolero Pick up van bearing Reg no- WB73C-4763 loaded with 59(Fifty Nine) cartoons of Mc Dowells NO-1 Whisky containing 24 Bottles of 375 ml each (seems to be duplicate). Total bottles-1461 i.e. 531 Lts marked as Exhibit-A and out of which one cartoon i.e 24 bottles of Mc Dowells NO-1 Whisky of 375 ml each (seems to be duplicate) taken as sample and marked as Exhibit-A1

I SI. Biswajit Ghosh of Detective Department, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted arrested three accused persons to the effect that on 01.09.21 at 18.55 hrs, received a secret source information that three persons were illegally carrying huge cartoons of liquor (seems to be duplicate) in a vehicle bearing registration no-WB73C-4763 (White colour Bolero Pick up) towards Ghoogomali road from Ambari side area without any valid license.

The information was diarised vide D.D, SPC GDE No-158 Dt- 01.09.21. Accordingly I informed the matter to ACP, DD, SPC and as per his kind direction myself along with SI Swadesh Saha, ASI Abu Taleb, ASI. Proloy Bhattacharjee, Const-682 SK Sabrati, Const- 1054 Arobindu Roy, Const. 371 Sushanta Dey all of DD, SPC left for Ashigarh more under Bhaktinagar PS to verify the veracity of the source information. This refers D.D, SPC GDE No- 159 Dtd- 01.09.21. On reaching at the spot at 19.40 hrs, sometimes after on being identified by the source, our team found that one vehicle bearing registration no-WB73C-4763 (Bolero Pick up) was crossed us towards Ghoogomali road. Our team managed to intercept the above noted vehicle at Ghoogomali main road, Badur Bagan in front of Laxmi Narayan Bhandar and apprehended the above noted three persons and found huge cartoons of seems to be duplicate liquor. On interrogation they disclosed their name and identity as noted above. On demand accused persons failed to produce any document or license for selling/processing liquor. They were running this business illegally without any valid license. On searched 59(Fifty Nine) cartoons of Mc Dowells NO-1 Whisky containing 24 Bottles of 375 ml each seems to be duplicate found in the said vehicle. They loaded the items from Fulbari area for selling it in open market of Siliguri area for their wrongful gain.

accused persons violated the provision of Bengal Excise Act. Accordingly, in presence of witnesses, I seized the vehicle loaded with seems to be duplicate liquor as noted above from the possession of accused persons under proper seizure list duly signed by the witnesses and accused persons, seizure was made on 01.09.21 in between 19.55 hrs and 20.50 hrs. Label the seized articles duly signed by the witnesses and accused persons. I arrested the three accused persons preparing memos of arrest and intimated their ground of arrest.

Hence, I pray to you that a specific case under proper section of law may kindly be started against the arrested three accused persons namely 1. Netai Saha (57) s/o-Lt Dinesh Ch Saha of Hakimpara, Near Dudh more, W/N-15 PS-Siliguri Dist-Darjeeling 2. Partha Saha (42) s/o-Lt Shasti Saha of Sanghoti more, w/n-38 PS-Bhaktinagar Dist-Jalpaiguri 3. Subal Das (54) s/o-Lt Radhanath Das of Baghajatin Colony, road no-2/5, w/n-02 PS-Pradhannagar Dist-Darjeeling and others and arrange for its investigation.
