In producing herewith the following Five (05) arrested accused persons namely 1) Sangam Saibo @ Sagar (22), S/O- Lt Prem Saibo of Majua Bedgara, P.S. Bhaktinagar, Dist- Jalpaiguri, 2) Binod Bhagat @ Kalu (28), S/O- Shiv mangal Bhagat of Debidanga, Kalkut, P.S. Pradhan nagar, Dist- Darjeeling, 3) Santosh Sahani (28), S/O- Lt Dipak Sahani of do, 4) Deb Roy (19), S/O- Lt Mani Kumar Roy of do, 5) Bikram Saibo (30), S/O- Unik Saibo of Sishabari, P.S.- Pradhan nagar, Dist- Darjeeling, along with the following seized articles:-

i) One iron made "Ram Dao", having length 31" (approx) including wooden handle recovered from the possession of Deb Roy.

i) One iron made "Ram Dao" having length 18" (approx) including butt, from the

iii) One iron "Rod" having length 42.5" (Approx), from the possession of Sangam Saibo @ Sagar .

iv) One Iron made "Sabol" having length 30" (approx) recovered from the

v) One Iron made "Sabol" having length 19" (approx) recovered from the possession of Santosh Sahani.

vi) One Steel made Eveready "Torchlight" from the possession of Santosh Sahani.

I, ASI Ratan Pradhan of Pradhannagar P.S, SPC would like to lodge this written complaint against the above noted accused persons to the effect that on 30.08.2021 at 00.25 hrs while performing PC night patrolling duty I received secret source information that 12/14 persons were assembled at Agham Singh Nagar, near Aluminum factory under Pradhan nagar P.S. area with deadly weapons with a view to commit some heinous crime. Accordingly without waste any time I informed the matter to you over telephone and as per your kind instruction at 00.35 hrs myself along with PSI Chetan Dangal, PSI Kalyan Saha, CV/645 Pankaj Gupta, CV/223 Swapan Chettri, CV/128 Ajay Sahani, CV/242 Rakesh Mangar, CV/646 Baban Ch Das, took departure for the spot vide GDE No 1963. We reached near the spot as confirmed by the source and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement. At about 00.50 hrs and we reached at Agham Singh Nagar, near Aluminum factory and found a group of 12/14 persons assembled and gossiping there. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing in multiple direction. Somehow, after a hot chase we could able to apprehend the 05 (five) above noted accused persons. On interrogation they disclosed that they along with other 7/8 associates with them had assembled there with a view to commit docoity

after making full preparation in a house at adjacent area. Thereafter all the apprehended persons were searched and due to late night I could not found any independent witness to be present at the time of search and seizure. During search I found the following articles were seized. i) One iron made "Ram Dao", having length 31" (approx) including wooden handle recovered from the possession of Deb Roy., ii) One iron made "Ram Dao" having length 18" (approx) including butt, from the possession of Binod Bhagat @ Kalu., iii) One iron "Rod" having length 42.5" (Approx), from the possession of Sangam Saibo @ Sagar , iv) One Iron made "Sabol" having length 30" (approx) recovered from the possession of Bikram Saibo., v) One Iron made "Sabol" having length 19" (approx) recovered from the possession of Santosh Sahani, vi) One Steel made Eveready "Torchlight" from the possession of Santosh Sahani

All the articles were seized between 01.55 hrs to 02.20 hrs issuing a proper seizure list duly signed by the accused persons. Thereafter all the persons were arrested with proper memo of arrest, and accordingly myself along with force with arrested accused persons returned back at Pradhan nagar P.S. at 02.35 hrs.

Under the above circumstances, I pray before you that a specific case may kindly be started against the arrested accused persons namely 1) Sangam Saibo @ Sagar (22), S/O- Lt Prem Saibo of Majua Bedgara, P.S. Bhaktinagar, Dist-Jalpaiguri, 2) Binod Bhagat @ Kalu (28), S/O- Shiv mangal Bhagat of Debidanga, Kalkut, P.S. Pradhan nagar, Dist-Darjeeling, 3) Santosh Sahani (28), S/O- Lt Dipak Sahani of do, 4) Deb Roy (19), S/O- Lt Mani Kumar Roy of do, 5) Bikram Saibo (30), S/O- Unik Saibo of Sishabari, P.S.- Pradhan nagar, Dist- Darjeeling and 7/8 other accused persons for assembling with deadly weapons with a view to committing docoity and arranged for its investigation under proper section of law and oblige thereby.
