I Rinku Sharma wife of Ashok Sharma resident of Surya Sen Colony, Block - E Part 2 near Kali Mandir Ward No. 34 of S.M.C, P.O. - Bhaktinagar, P.S- NJP, District Jalpaiguri, Pin - 734007 would like to inform you that Ratan Sharma @ Tunu is my younger brother in law who have left the house of my father-in-law and mother-in-law when he was aged about 16 years and break all the relation with them and resided just backside of our house with Mina Mitra (now deceased) and married to her daughter in the year 2009. That my father-in-law was died in the year 2019 and my mother-in-law shifted to Bihar permanently and resided with my younger brother-in-law. That thereafter this incident said Ratan Sharma @ Tunu forcefully occupied the room of my mother-in-law and younger brother-in-law just after the death of my father-in-law and started to live in our house alongwith his family. That on 25.08.2021 at about 7.30 I kept some cooking wood inside my boundary but said Ratan Sharma @ Tunu stubborn in nature suddenly came to me and started to beat me with

there is a nail scratching marks in her face and in the hands which are very painful for her and still her treatment is going on.

Under the above circumstances I hereby lodge this complaint against the abovenamed miscreants and request you to kindly look into the matter so that the wrongdoer can be punished as per the procedure established by law.
