Sir,

I, Guriya Singh, Wife of Manish Singh R/o- New Colony, ward no-3, Post Office-Champasari Police Station-Pradhan Nagar, District Darjeeling would like to lodge this F.I.R against my husband Manish Singh (Husband), Harish Singh (Father-in law), Phulkeshwar Singh (Mother-in-law) and other in-laws mentioned above.. Our marriage was solemnized on 7th May, 2017 at Siliguri as per Hindu rights and customs. After marriage my husband brought me in his residence at Champasari, P.O. - Champasari, P.S. - Pradhan Nagar, Dist. Darjeeling and we started to live together as husband and wife. On 03/08/2018, one male child namely Ankit Singh was born out of wedlock.

Since the inception of the marriage my husband, father-in-law, mother-in-law and other in-laws has been torturing me both physically and mentally for not bringing enough dowries from my paternal home and was treated in a manner not expected for any human being to live with self-dignity and was maltreated, beaten, starved and abused.

When I got pregnant again with my second child my husband and in-laws started to pressurize me to undergo ultra sound as they didn't want a girl child which is illegal.

On my protest, my husband, my mother-in-law, father-in-law, tortured and forcefully fed me an abortion tablet and due to continuous bleeding I was admitted in Department of Health and Family Welfare Hospital, Siliguri and got discharged on 11/5/2019. I was threaten to not make any complaint before doctor or anyone else regarding such forced abortion or else I will be deserted and given divorce.

One day before dhanteras in October, 2019 my husband even attempted to kill me by strangling dupatta around my neck and when he failed, he picked up a knife to strike me. Somehow I managed to escape. On 25/02/2020 I was abused and tortured severely by husband and in-laws and due to severe injury I went under treatment at Siliguri Government of Health and Family Hospital.

Abhishek Singh son of Rinku Singh had taken non-consensual video when I was bathing. Abhishek Singh and his mother Rinku Singh threats and blackmail to leak those explicit photos and videos. I was treated in a manner not expected for any human being to live with self-dignity and was maltreated, beaten, starved and abused.

My husband refused to maintain any matrimonial relation with me and having no other alternative I had to reside separately in a rented house at New Colony, Ward No-3, Pradhan Nagar, and District- Darjeeling. Though my husband have deserted me since the month of March, 2020. I have not taken any action that I been suffering from desertion as well as has been suffering from mental cruelty and my husband and in-laws have committed many matrimonial and criminal offences. These people have also taken possession of my jewelry and clothes (Stridhan).

Since last few days he has been frequently entering into my house premises forcibly to assaults me and abuses me with filthy languages. He threatened me

with dire consequences if I approach before the police station. In the above circumstances I am worried about my life and therefore request you to take necessary legal action against my husband to save me along with my son life.

Sir, I am helpless in condition and therefore, I pray to take necessary legal action against my above Husband and in-laws. Hope your kind co-operation and needful action please.
