1. Sl. Shyamad Dutta Roy of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted accused persons to the effect that today i.e on 30.08.21 at 15.25 hrs I received a specific source information that 02 (two) persons would be coming from Jalpiguri side and proceed towards Bhola More side under NJP PS with a suspected consignment of Ganja in a motor cycle without displaying any number plate. Accordingly, I informed the matter to SI Samir Tamang, O/C New Jalpaiguri PS. SPC and diarized the fact in General disary vide NJP PS GDE No. 1552 dated 30.08.21 and as per order myself along with ASI Khagen Barman, ASI Sajal Das, VP/08 Laxman Rov. VP, 13 Jamirul Islam, CV/525 Niru Yadav and CV/306 Biswajit Roy, all of NJP PS left, PS for Bakravita opposite of Tea Park under NJP PS vide GDE No 1553 dated 30.08.21 &-M.C.C. No 1541/21 Date: 30/08/21 to verify the veracity of the information by Govt. Vehicle taking all necessary articles like white paper, Digital weighing machine, Arrest Memo, Seizure List, seal, gala wax, candles, match box etc. Meanwhile, I called two disinterested witnesses namely Ranjit Ghosh S/O Sunil Ghosh of Surya Sen Colony, Block - E. PS. NJP. Dist. Jalpaiguri and 2) Saumya Bikash Ghosh S/O Jyoti Prakish Ghosh of Purba Dhantala, PS NJP, Dist.- Jalpaiguri. I disclosed our identity and informed them about the information in hand and requested them to accompany with us in the whole process of search and seizure, if any in which they agreed. At about 15.55 hrs we arrived at Bakravita opposite of Tea Park and our Police party started looking for accused persons and smalls noticed that the above noted Motor cycle (Activa scooty) without displaying any number palete is coming from Gora More Side and proceeding towards Bhola More. We managed to detained the said Motor cycle at Bakravita opposite of Tea Park and found two person bounded the said motor cyle I asked the rider of the motor cycle to park the motor cycle beside the road. I disclosed our identity to them. On being asked they disclosed their names and address as noted above and found one Rana Banerjee S/O Purnendu Banerjee of Mamata Para was driving the motor cycle. I told them about the information in hand and they denied. After prolong interrogation, finally they admitted that there is three packet of Ganja in the front passage of the Motor cycle (Activa Scooty). Then, I gave them option that whether they wanted to be searched in presence and supervision of Executive Magistrate or police Gazette Officer. They agreed to be searched in presence of police Gazette Officer. Accordingly, I served the Notice in writing and as per provision of law to them which they duly acknowledged by receiving and signing in the copy of notice. Then, I informed Shri Pasang Topgay Bhutia, WBPS, ACP-Traffic (West), SPC regarding the apprehension of said accused persons with said to be Ganja and requested him through messenger to come at Bakravita opposite of Tea Park under NJP PS and remain present as Gazette Officer during the time of search and seizure if any which he duly accepted.

Then, I, in presence of witnesses and under the persons except the difference of Shri Pasang Topgay Bhutia, WBPS, ACP-Traffic (West), SPC, searched the detains ( Mana cycle and found (03) three packets said to be Ganja Wrapped with Brown colour tape in the front passage of the Motor cycle (Activa Scooty) without displaying any number plate On demand, in presence of the Gazette Officer Shri Pasang Topgay Bhutia, WBPS, ACP Traffic (West), SPC as well as independent witnesses they failed to produce any valid document in support of possessing/procurement of said to be Ganja which were kept in the front passage of the motor cycle without displaying any number plate.

I, accordingly, weighed the said to be Ganja by Digital weighing instrument taken by us and found 7.2 kgs of said to be Ganja in each packet i,e total total 21.600 kg said to be Ganja in 03 (three) separate packets and marked as Exhibit 'A", 'B", & 'C'. seized from Motor Cycle (Active Scooty) without displaying any number plate Accordingly, I seized, sealed and labeled the entire article in presence of Shri Pasang Topgay Bhutia, WBPS, ACP-Traffic (West), SPC and independent witnesses and accused persons which was acknowledged by the accused persons. The search, seizure and labeling was made between 18.15 hrs to 19.25 hrs. Then, I arrested the above noted accused persons after observing all guidelines of Apex court as they violated the provisions of Narcotic Drugs by possessing said to be Ganja without any valid authority, document or license. On interrogation the accused persons as noted above, admitted that they procured the said to be Ganja from Jalpaiguri side for the purpose of making money illegally.

Under the above fact and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the accused persons namely namely (i) kana Banerjee (20 yrs) S/O Purnendu Banerjee and (ii) Gopal @ Abinash Mahato (20 yrs) S/O Rajendra Mahato both of Mamatapara, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
