With due regards, I, **SMT. TANIA BHOWMICK (DAS)**, Wife of Sri Aritra Bhowmick, Daughter of Sri Kartick Chandra Das, Presently residing at Netaji Subhas Road, Ward No. 20 of S.M.C., Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling, Pin: 734001, would like to lodge this written complaint to the effect that my marriage was solemnized on 10.12.2020 with **SRI ARITRO BHOWMICK**, Son of Sri Sekhar Bhowmick, Resident of M.M. Sarani, Lake Town (West), P.O. - Bhaktinagar - 734007, P.S. N.J.P., Dist. Jalpaiguri, according to Hindu Rites and Customs after observing all formalities on and from Gramin Bank Bhawan, Fulleswari and at the time of marriage, my parents and nearest relatives have given so many valuable articles like golden and silver ornaments, furniture & fixtures, utensils and other valuables including cash as per the demand of my husband and his family members and presently, all the articles which are stridhan lying in the care and custody of my husband and his family members. It is to be mentioned here that our marriage was negotiated marriage and our marriage was negotiated through the News Paper Advertisement of Uttarbanga Sambad and thereafter, with the intervention of our family members, the said marriage was took place. It is also to be mentioned here that prior solemnization of our marriage, we have met with each other on several occasion in order to develop our bonding and at that time, both of us have assured each other that we have no previous relation with anyone. After marriage, my husband brought me at my matrimonial house and I went to my matrimonial house with lots of dreams and hope with a view to lead happy conjugal life with my husband but immediately after completion of the marriage, when we entered into the room, my husband has confessed and told me that he was/is not ready and willing to marry with me as he has been maintaining a relationship with another lady prior to our marriage and he wants to marry with the said lady but due to the pressure of his family members, he has compelled to give his consent in the said marriage and clearly stated that he has no love and affection towards me as his legally married wife and hearing the same, I fully mentally broken down and when I asked him as to why, he did not told the same before our marriage and in reply, my husband stated that there was no option in his hand otherwise to marry me as his family members have created pressure upon him to do so. It is to be mentioned here that inspite of hearing the said news, I went to the house of my husband accompanied with him as he has assured me that in future, he will not keep any such type of relation with his ex-girlfriend but it is my husband and his family members who have started tremendous torture upon me both physically and mentally immediately after few days of our marriage. I have been

to safeguard themselves from the legal consequences, he had sent the said notice and in fact, he had/has no such intention to lead further conjugal life with me and also abused me and my well wishers with filthy and dirty languages and threatened us if we came again, he will not hesitate to ruin my life and property. Sir, on 29.08.2021, my husband has posted a Status in his Facebook Profile by mentioning that "n\*de pic with close one I have uploaded in website, for more u can inbox me or login [www.://uploadccind.in](http://www.://uploadccind.in)) for malign my reputation before the society.

I, therefore, request you to investigate into the matter and please take appropriate strong legal action against my husband Sri Aritro Bhowmick, my father-in-law Sri Sekhar Bhowmick, my mother-in-law Smt. Mridula Bhowmick and others as mentioned aforesaid as per the provision of law and obliged thereby.
