Respected Sir,

With due respect, I, **SRI PINTU KUMAR SAH**, Son of Lal Babu Sah, Resident of Satsang Ashram Road, Near Bibadi Club, N.J.P., Ward No. 35 of SMC, Siliguri, P.S. N.J.P., Dist. Jalpaiguri, would like to lodge this Written Complain to the effect that I am the Registered Owner of a Four wheeler Mahindra Bolero Pick Up vehicle bearing Registration No. **WB-73D-0606**, Engine No. **GHD1E39590**, Chassis No. **MA1ZN2GHKD1F48440**, and I have purchased the said vehicle after accumulating my hardest money with an intention to ply the said vehicle for commercial purpose and the said vehicle is the only earning source of myself as well as my family members. After purchasing the said vehicle, I have been using the same on hire basis. Sir, considering my age, I could not look after my said vehicle properly and I have decided to sold out the said vehicle. In the mean time, one person namely Pranab Acharjee, Of Netaji Subhas Road, Subhas Pally, Ward No. 18 of SMC., Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling having Mobile No. 99071-06318, have contacted with me and also visited my residence in order to look after the said vehicle and also approached and induced me to handover my said vehicle in his favour on Lease basis under certain terms and conditions and also assured me that if I handover the said vehicle in his favour, he will comply all the conditions which he has agreed. On being induced by said Pranab Acharjee, I have agreed to handover my said vehicle in his favour on lease basis and accordingly, a Deed of Agreement for Lease was executed in between myself and said Pranab Acharjee on 13.08.2021 in presence of witnesses under certain terms and conditions and accordingly, after execution of the said Deed of Agreement for Lease, I have handed over my said vehicle in his favour to which, he has acknowledge the same as having received. Sir, as per the Lease Agreement, said Pranab Acharjee being the Lessee shall pay a sum of Rs. 26,000/- only per month to me on or before 15th of the succeeding month and after

completion of the said Lease Agreement, he shall return back my said vehicle as it is condition in my favour. Sir, after completion of one month and within the period of 15th August, 2021, when the Lessee has failed to pay the monthly hire charges against the said vehicle, I tried to contact with him over phone and every time, said Pranab Acharjee has delayed the matter on different pretext and assured me that he will pay the amount within a very few days but till today, he did not pay any amount against my said vehicle and still now, the vehicle is in the possession of said Pranab Acharjee. Thereafter, when he tried to bypass the matter and ignored me to pay the month hire charges amount within the stipulated period, I tried to contact with him personally but could not succeed and thereafter, I went to his residence in order to find out my vehicle as well as locate the said person namely Pranab Acharjee and after reaching there, I came to learn that he has misappropriated money of several persons and thereby deceived several persons by this way. Finding no other alternative, I again tried to contact on his mobile and asked him about the whereabouts of my vehicle but he did not give any satisfactory reply to that effect and also did not say anything about the whereabouts of my said vehicle and it is my strong apprehension that he might be used my said vehicle for illegal purposes and he may dispose off my said vehicle for his wrongful and illegal gain and by this way, he deceived and cheated me.

I, therefore, request you to kindly investigate into the matter and please take necessary legal action against said Pranab Acharjee as per the provision of law and also recover my said vehicle from the custody of said Pranab Acharjee and obliged thereby.
