In producing herewith one arrested accused person namely Ashok Sharma (22) S/O Mahabir Sharma of Durganagar Iscon Mandir,Road ,Ps.Bhakti Nagar,Dist-Jalpaiguri along with following seized articles viz;-

- (i) 528 (five hundreds and twenty eight) strips of "Winspasmo Forte" capsules, (each capsules contains Dicyclomine Hydrochloride IP 10 mg, Tramadol Hydrochloride IP 50 mg, Acetaminophen IP 325 mg) B/No.WPS519027,mfg Sept 2019 Exp August 2021, each strips containing 10 capsules(Total capsules 5,280) kept in a white gunny bag recovered from the exclusive possession of accd. Ashok Sharma, marked as Exhibit-A, In which 02(two) strip taken as sample for chemical analysis marked as exhibit-A-1
- (ii) Loose "Winspasmo forte" capsules in a Black colour polythine (plastic) which was kept inside the said white gunny bag total 7,200 pieces capsules from the possession of accd. Ashok Sharmarnarked as Exhibit -B, from which 20pieces of loose capsules taken as sample for chemical examination marked as Exhibit-B-1.

(Total 12,480 pieces" Winspasmo Forte" capsules recovered from the exclusive possession of accused Ashok Sharma)

I SI- Haren Kumar Mohanta presently of Pradhan Nagar PS, SPC would like to lodge a written complaint against the above noted accused persons to the effect that on 01.09.21 at about 20:15 hrs. I received a specific source information that one person will come with huge quantities of spurious drugs to deliver the same to his designed agents /customer at State Guest House more under Pradhan Nagar Ps/SPC. The information was diarised vide Pradhan Nagar Ps GDE no. 55 dt. 01.09.21 and informed you and as per your direction I along with my team SI.Binup Mahato, PSI.Chetan Dongal, PSI.Kalyan Saha, ASI. Ratan Chetri, , CV/223 Swapan chettri and CV/242 Rakesh Mangar, all of Pradhannagar PS, SPC left for State Guest House more under PS Pradhannagar by Govt. vehicle to verify the veracity of the information. The matter was duly diarized in general dairy at Pradhannagar vide GDE No. 57 dt. 01.09.21. At the time of departure from office I took investigation kit and arrived at 20:35hrs at State guest House More under PS Pradhannagar and waited there , and called two independent witnesses namely (i) Santosh Sah(32) S/O Rajendra Sha of Green Park, Tea Auction Road, Ps Pradhan Nagar, Dist-Djg, (2) Debu Mohanta (36) s/o Birendra Nath Mohanta of Ganesh Ghosh Colony, Ps. Pradhan Nagar, Dist-Darjeeling and disclosed our identity and informed them about the information in hand and requested them to accompany us in the whole process of search and seizure if necessary. Source identified us one person who were coming and reached at state guest house more with a big gunny bag in his right hand. Accordingly, we cordoned the person who disclosed his identity as Ashok Sharma (22) S/O Mahabir Sharma of Durganagar Iscon Mandir, Road , Ps. Bhakti Nagar, Dist-Jalpaiguri and detained him. On interrogation the accused person confessed that he is selling drugs since long without any valid documents at Champasari area under Pradhan Nagar Ps area and possessing huge quantities of "Winspasmo Forte" Capsules.

Then I gave him option whether he wanted to be searched in presence of Executive Magistrate or by any Gazetted Officer he agreed to be searched by any one of them. Further I served him a notice in accordance with provisions of law in this regards. I also offered the independent witnesses and the accused person to search Police Party as per provision, but he refused to search the police party. Accordingly, I called Sri Subhasis Chaki, I/C, Pradhannagar PS, to act as Gazetted officer, he arrived at the spot at abour 21:25hrs and disclosed his identity to the detained persons as well as witnesses a Gazetted Officer. Under supervision of Sri Subhasis Chaki I/C Pradhannagar PS and in presence of two independent public witnesses, the above noted accused person was searched, following all formalities to keep his decency and found & seized Total 12,480 Hydrochloride IP 50 mg, Acetaminophen IP 325 mg, . I accordingly seized all the articles and also extract samples, labeled and sealed the article in presence of the Sri Subhasis Chaki, I/C Pradhannagar PS, SPC independent witnesses and accused

persons. The seizure was made between 21:25 hrs to 22:45 hrs. He further confessed in presence of Sri Subhasis Chaki, I/C Pradhannagar PS, SPC and other witnesses that he procured such drugs clandestinely from elsewhere for the purpose of selling the same in high rate at Champasari area under Pradhan Nagar Ps to his different agent and customers for his personal gain by illegal means. On interrogation he disclosed that he is dealing in such business of drugs selling illegally since long with one Sagar of Botol company under Bhaktinagar Police station, JPG and others. Then I arrested the above noted accused persons namely Ashok Sharma (22) S/O Mahabir Sharma of Durganagar Iscon Mandir, Road , Ps. Bhakti Nagar, Dist-Jalpaiguri after observing all formalities of arrest as well as disclosing the cause of arrest and returned to Ps.

On the above circumstance, I pray before you to start a specific case against the above noted accused person Ashok Sharma (22) S/O Mahabir Sharma of Durganagar Iscon Mandir,Road ,Ps.Bhakti Nagar,Dist-Jalpaiguri under proper section of law and arrange for its investigation.
