Respected Sir,

With due respect I, **RENUKA GOSWAMI**, D/O Sib Narayan Goswami, W/O Ajit Sarkar, resident of Kalabari, Champasari, P.O. Champasari, P.S. Pradhan Nagar, Dist - Darjeeling, West Bengal - 734003 begs to state that on 19.07.2019 my marriage was solemnized with Ajit Sarkar, S/O Deepak Sarkar, resident of Om Nagar, Ward No. 8, Araria, P.O., P.S. & Dist - Araria, Bihar under Hindu rites and customs. After the marriage my husband took me to his place of residence at Araria. After three months of my marriage, my mother in law i.e. Parvati Sarkar, father in law i.e. Deepak Sarkar, brother in law i.e. Amrendar Sarkar and Kusboo Sarkar, W/O Amrendar Sarkar along with my husband started physical and mental torture upon me on the demand of Dowry with a tune of Rs. 2,00,000/- (Rupees Two Lakhs only). When I refused to make a call to my parents to fulfill the demand of my in-laws, their torture started increasing day-by-day. That in the month of December 2019, I got pregnant and when I was three months pregnant my husband, keeping me in the dark, gave me some medicine due to which my three months unborn baby died in my womb. That thereafter I again got pregnant in the month of March, 2021. After getting the knowledge of my pregnancy, my in-laws including my husband started torturing me and also assaulted me with fist and blows and drove me out from my matrimonial house and kept all my Gold ornaments and belongings with them. That somehow I managed and came to my parental house. That on 09.07.2021 my uncle and other relatives went to my matrimonial house to request them to provide shelter to me and my uncle, at the relevant time, also gave Rs. 40,000/- (Rupees Forty Thousand only) to my husband for smooth running of my matrimonial life. That in the last week of July, my husband and my brother in law came to my parental house at Champasari and without any rims and reason started quarrelling with me and my husband with an intention to kill my unborn baby, kicked me in my stomach. That after two days my unborn baby died in my womb at my parental house. That my husband is very desperate in nature and there is every possibility that he might take my life. I could not lodge the complaint earlier as I was in trauma and pain of losing my child in my womb.

So I therefore request you to kindly look into the matter and start a specific case against the above named persons and do the needful under the provisions of law.

I shall be highly obliged for this act of kindness.
