With due respect I, **Bishnu Prabha Chhetri**, Wife of Late Tilak Bahadur Chhetri, being one war widow resident of Sainikpuri, B-Block, P.O. New Champita, P.S. Matigara, Dist. Darjeeling, PIN:-734009 would like to inform you that Kama Chhetri (now deceased), Son of Late Ganesh Bahadur Chhetri was the sole absolute owner in possession of land measuring about 2 katha in Mouze Khoplashi, J.L. no. 21 near chunabhatti, Khaprail, P.O. New Champita, P.S. Matigara, Dt. Darjeeling. during the life time of Kamal Chhetri (now deceased) was searching intending purchaser for sale his aforesaid land measuring about 2 kathas at and for the price of Rs. 1,00,000/- (One lac) only that time I had accepted his proposal and agreed to purchase the land at and for the above said price. One written agreement executed by Kama Chhetri (now deceased) in one part and my I am in another part as purchaser on 02.03.2005 and Kamal Chhetri (now deceased) agreed to sale the below schedule land to my client at and for the price of Rs. 1,00,000/- (One lac) only on condition to sale the land as soon as possible to me and I had paid total a sum of Rs. 50,000/- (Rupees fifty thousand) only in cash Kamal Chhetri (Now deceased) as an advance/baina money against the below schedule land and he had received, accepted and acknowledge the same and also promised to register the below schedule immediately. Thereafter ten years before Kamal Chhetri died intestate and without complete the sale or registrar the aforesaid land in favour of me. During the life time of Kamal Chhetri and after the demise of Kamal Chhetri his wife **Chandrakala Chhetri** induced me to pay the balance consideration money in respect to abovesaid agreement and also assured me to registrar the land through her husband or in absence his husband she and her son namely **Suraj chhetri** shall registrar the land in my
