Sir,

in producing herewith one arrested accused persons namely Syamal Barman(48) S/o Lt Kamini Barman of Naya Bazar, Debidanga, PS Pradhan Nagar, Dist: Darjeeling along with one Truck bearing Registration No WGY 4465 loaded with river bed sand and material seized under proper seizure list.

I, SI Niranjan Paul of P.S Bhaktinagar, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted arrested accused persons along with the owner of Truck bearing Registration WGY 4465 and others to the effect that on 03.09.2021 at about 13.40 hrs along with force were performing K-37 Mobile van duty at Salugara area vide GDE No 135 Dated 03.09.2021. I received source Information that one Truck bearing Registration No WGY 4465 loaded with illegal River Bed sand and Material is coming from Bedgata River side and going towards Salugara, under Bhaktinagar PS. Accordingly, I shared the information with I/C Bhaktinagar P.S, SPC over telephone and as per his kind verbal direction, I along with my force had been to Dimdima, Salugara and placed a Naka there and started checking a vehicle coming from Eastern by pass . At 14.05 hrs, one Truck was seen coming Saluagar Bazar and as being indicated by the source, we apprehended one Truck bearing Registration No WGY 4465 along with its driver. Seeing the activities of the driver, there was reason to believe that there was something illegal in the truck. Accordingly, I checked the vehicle and found the truck loaded with river bed sand on demand, the driver of the Truck disclosed his name and identity as noted above. Further, on demand he failed to produce any valid documents related to the Truck as well as the loaded River Bed sand materials, pebbles in the Truck. Hence there was reason to believe that the driver of the Truck and his helper had procured the vehicle along with its loaded river bed material illegally and transporting the same for their illegal gain,

On further grilling they discloses that they along with the owner of the Truck in association with had procured the river bed materials, pebbles illegally from Bedgara Riverside and carrying/transporting the same to Salugara Bazar for their wrongful gain without any valid documents. Hence, I seized the Truck bearing Registration No. WGY 4465 along with loaded sand under proper seizure list and arrested the driver of the Truck U/s 41 Cr.P.C under proper Memo of Arrest after explaining the reason of arrest to him . The whole process of search, seizure and arrest took place in between 14.20.hr to 14:55 hrs.

Under the circumstances, I pray before you that kindly initiate a specific case against arrested accused driver namely Syamal Barman(48) S/o Lt Kamini Barman of Naya Bazar, Debidanga, PS Pradhan Nagar, Dist: Darjeeling along with his owner of vehicle Registration No. WGY 4465 and others under proper section of law and cause its investigation.
