In producing herewith one accused person namely Amit Roy (18yrs) male S/o. Ates ar Roy of Sir, Vill+PO. Manuagachh, PS-NJP, Dist- Jalpaiguri along with the following seized articles as per proper seizure list

- (1). One Truck (Saktiman) bearing registration no. WGR-1189 loaded with 20 (twenty) CFT
- I, ASI. Jamirul Haque of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that on 01.09.2021 at 07:55hrs myself along with C/824 Satyaban Das & NVF 029-Kiran Roy both of Ambari-Falakata OP, PS. NJP/SPC detailed for performing K-39 Mobile van duty vide MCC No. 2287 Dated: 01.09.2021. In course of van duty at about 13: 02 hrs I received an information from my source that one Saktiman Truck loaded with sand coming from Gadheya Gachh, Village Road side without any document. Accordingly I informed the matter to O/C Ambari-Falakata OP over telephone and as per his direction, myself along with force arrived at Gadheya Gachh, Village Road on 01.09.2021 at 13: 05 hrs and found one Saktiman Truck loaded with sand coming from Gadheya Gachh, Village Road side. Seeing the Police party the driver of said Saktiman Truck and Khalasi/Labour fled away, but managed to intercept the above noted Saktiman Truck with one Khalasi/Labour Amit Roy (18yrs), male S/o. Ateswar Roy of Vill+PO. Manuagachh, PS-NJP, Dist- Jalpaiguri. On interrogation, the above noted person disclosed his name and identity as noted above. On being asked, the above noted accused person failed to produce any valid document for possessing the sand inside the Saktiman Truck as well as the documents of Saktiman Truck. There is sufficient reason to believe that the above noted Khalasi/Labour have stolen those sand from Kartowa river without any legal royalty/ papers as per rule, for selling clandestinely. Accordingly, I seized the said Saktiman Truck loaded with 20(twenty) CFT Sand (bearing registration no. WGR -1189) under proper seizure list and arrest the above noted person U/S 41 Cr.P.C informing him the ground of arrest after issuing Memo Of Arrest . The search, seizure and arrest were made in between 13:05 hrs and 13:25 hrs on 01.09.2021.

I therefore request you a specific case may kindly be started against the accused person namely Amit Roy (18yrs) male S/o. Ateswar Roy of Vill+PO. Manuagachh, PS-NJP, Dist- Jalpaiguri and owner of the above noted seized Saktiman Truck under proper section of law.
