Respected Sir,

I, **SRI ASHISH SHARMA**, S/o Ratan Lal Sharma, resident of
S.F. Road, Jaliguri, P.O. & P.S. Siliguri in the District of
Darjeeling - 734005, the Manager of **M/S MANSAROVAR TEA PRIVATE
LIMITED**, would like to lodge a complaint stating as follows:

1. That our company purchased all that piece and parcel of land measuring 12 Decimal appertaining to and forming part of R.S. Plot No. 150 corresponding to L.R. Plot No. 201 & 202 of Sheet No. 1 recorded in R.S. Khatian No. 5/1 corresponding to L.R. Khatian No. 163, 198, 235, 246, 272 & 304/1 of Mouza - Ambari Falakata in the District of Jalpaiguri by virtue of a registered Deed of sale executed by Ratan Kumar Goel, Director of Cradle Computers Pvt. Ltd. and registered at the office of the Additional District Sub-Registrar, Rajganj and recorded in Book No. 1, Volume No. 2, Pages 4462 to 4479, being Document No. 715 for the year 2010 and in possession of the aforesaid land.
2. That since last one month 1. Suresh Kumar Jain; 2. Naresh Kumar Jain; 3. Rajesh Kumar Jain & 4. Sanjoy Kumar Jain; all are son of Sri Prasanna Kumar Jain, resident of Burdhwani Road, P.O. & P.S. Siliguri in the District of Darjeeling along with their men and associates have been trespassing into the Company's land along with several antisocial elements with an intention to construct a hut over the land and take forceful and illegal possession of the company's land but as the factory is just behind the land, they could not do any harm.
3. That finding no other alternative, a case was filed under Section 144 of Cr.P.C., before the Learned Executive Magistrate at Jalpaiguri, being Petition Case No. 726 of 2021 and the Learned Court was pleased enough to pass an order "... O.C. N.J.P. Police Station to take suitable step so that any untoward incident involving the said property can be avoided".
4. That despite of having complete knowledge of the said order passed by the Learned Court, yesterday again around 11:30 p.m., the aforementioned 1. Suresh Kumar Jain; 2. Naresh Kumar Jain; 3. Rajesh Kumar Jain and 4. Sanjoy Kumar Jain along with
