Respected Sir,

This is to inform you I, Sri Sagar Mohanta, Son of Late Provash Mohanta, resident of Kamarpara, Road No.2, Thakurnagar, P.O. Sahudangihat, P.S. NJP, Dist. Jalpaiguri is presently the Dabgram-Fulbari Block Trinamool Congress President. That yesterday i.e., 5th September, 2021 on the eve of Teachers' Day a day-night football tournament was organized at an open space beside my abovementioned residence. That during the course of the said football tournament, (1) Suman Chandra Das, Son of Biren Chandra Das, Gouranga Das, Son of Haripada Das, (3) Chitta Karmakar, (4) Chiranjit Karmakar, Son of Chitta Karmakar, (5) Parimal Ghosh (fisherman by occupation), all resident of Dakshin Shantinagar, P.S. MJP, Dist. Jalpaiguri, alongwith 60 to 70 unknown miscreants gathered at the abovementioned football tournament venue and they started to instigate the local people by using dirty and filthy slang languages towards the local residents gathered there (which also included the women of the said locality) and also by misbehaving with them. That presently I am in great distress and am threatened that the said Suman Chandra Das, Gouranga Das, Chitta Karmakar, Chiranjit Karmakar, Parimal Ghosh alongwith their men can cause harm to my life.

Hence it is prayed before your goodself to kindly look into the abovementioned matter and take necessary legal action against the abovementioned Suman Chandra Das, Gouranga Das, Chitta Karmakar, Chiranjit Karmakar, Parimal Ghosh alongwith their men as per the due course of law and provide me with justice.
