Bhaktinagar, would like to inform you that my marriage was solemnized with Santosh Saha on 27.02.2004 and thereafter we started to live together as husband and wife at my matrimonial home and out of our wedlock one son namely Sahil Saha and one daughter namely Sanchita Saha were born. Further I would like to inform you that after 2 - 3 months of my marriage I came to know that my husband is a habitual drinker and he consumes alcohol on each and every day. Under the influence of alcohol he used to torturing me, my son and daughter mentally and physically every day. Since six months my husband used to ask me to bring a sum of Rs. 100000/- from my parents for his business. On 01.09.2021 my husband bit my children and me with his fist and blows and he had also cut the hair of my son by scissor. My husband is an alcoholic and he drinks every day in front of my children. On 04.09.2021 at about 1 A.M. under the influence of alcohol my husband locked out me and my children outside the house in the rain, several times I knocked the door to go inside but Chargemy husband did not open the door. I further begged him to open Shinkinger Pelice Station door for the sake of the children but he did not paid any heed to the same and accordingly we stayed outside the house at that night. I and my brother went to the Siliguri District Hospital for treatment of my brother
