UP 25 H 3360 11.WB 64 E 3553 12.SK 01 P 4389 Maruti Alto. The way bridge and the wall of the cold storage also partially damaged. Searching of full brunt vehicles and articles is going on with the help of PS property register. During investigation full brunt vehicles and articles may be traced.

Seeing the intensity of fire it appears to me that some unknown miscreat committed the said mischief by fire in respect of Govt. property with some malafide intention.
