In producing herewith accused person namely Mithun Gowala (35 yrs) S/O late Raju Gowala Vill- Jhanjupara, PO- Fatapukur, PS- Rajganj, Dist - Jalpaiguri of along with the following seized articles under seizure as per seizure list:

Total 02 (two) following packets wrapped with Black colour tape containing (i) 13.800 kgs and (ii) 11.500 Kgs of said to be ganga and (iii) 01 following Packet wrapped with Brown colour tape containing 07.100 kgs of said to Ganja i.e. total 32.400 kgs said to be Ganja Marked as follows -

- i) Exhibit 'A' Contains 13.800 kgs Said to be Ganja wrapped with Black colour Tape.
- ii) Exhibit- B' Contains 11.500 kgs Said to be Ganja wrapped with Black colour Tape.
- iii) Exhibit- 'C' Contains 7.100 kgs Said to be Ganja wrapped with Brown colour Tape.
- iv) Exhibit "D" one nylon bag.
- v) Exhibit- "E" one nylon bag
- One Black Colour Bajaj Pulser (220) Motor Cycle without displaying any number

I, SI Samik Paul of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted accused person to the effect that today i.e. received a specific source information that 01 (one) person on 07 09.21 at 12.40 hrs 1 would be coming from Fatrapukur side and proceed toward Siliguri side with a suspected consignment of Ganja in a Pulser Motor Cycle without displaying any number plate. Accordingly, I informed the matter to SI Samir Tamang, O/C New Jalpaiguri PS, SPC and diarized the fact in General disary vide NJP PS GDE No. 306 dated 07.09.21 and as per order myself along with ASI Khagen Barman, ASI Sajal Das, VP/08 Laxman Roy, VP/13 Jamirul Islam, CV/525 Niru Yadav and CV/306 Biswajit Roy all of NJP PS left PS for Jiaganj. Opposit Jiaganj Petrol Pump under NJP PS vide M.C.C. No 1705/21 Dated 07/99/21 to verify the veracity of the information by Govt. Vehicle taking all the necessary articles like white paper, Digital weighing machine, Arrest Memo, Seizure List, seal, gala wax, candles, match box etc. Meanwhile, I called two disinterested witnesses namely (i) Najarul Islam S/O Sanibulla Md of Pradhan Para, PO-Fulbari Hat, PS-NJP, Dist.-Jalpaigurí and (ii) Sukamal Sengupta S/O late Subir Sengupta of Shaktigarh, Road No-3, PS NJP, Dist. Jalpaiguri. I disclosed our identity and informed them about the information in hand and requested them to accompany with us in the whole process of search and seizure, if any in which they agreed. At about 13.05 hrs we arrived at Jiaganj, near petrol pump and our Police party started looking for accused person and finally noticed that the above noted Pulser Motor Cycle without displaying any number plate is coming from Fatapukur side and proceeding towards Siliguri side. We managed to detained the said Motor cycle at Jiaganj, opposite Jiaganj Petrol Pump. I asked the rider of the Motor Cycle to park the motor cycle beside the road. I disclosed our identity to him. On being asked he disclosed his name and address as noted above. I told him about the information in hand but he denied. After prolong interrogation, finally he admitted that there is two nylon bags containing three packets of Ganja in two nylon bags in his motor cycle. Then, I gave him option that whether he wanted to be searched in presence and supervision of Executive Magistrate or police Gazette Officer. He agreed to be searched in presence of police Gazette Officer. Accordingly, I served the Notice in writing and as per provision of law to him which he duly acknowledged by receiving and signing in the copy of said notice. Then, I informed Shri Manabendu Sekhar Rakshit, WBPS, ACP-Traffic (HQ), SPC regarding the apprehension of said accused person with said to be Ganja and requested him through messenger to come at Jiaganj, near Jiaganj Petrol Pump under NJP PS and remain present as Gazetted Officer during the time of search and seizure if any which he duly accepted.
