(ii) Two bottles of "Cefrex" Cough Syrup (Chlorpheniramine Maleate & Codeine Phosphate Syrup) containing 100 ml each taken as sample from the exhibit-A and marked as Exhibits-A1.

(iii) One old bicycle.

I, SI Ashim Kr Das of Panitanki TOP under PS Siliguri, Siliguri Police Commissionerate, do hereby lodge this written complaint against Sahadab Barman S/O Sudha Ranjan Barman (2) Niranjan Das S/O Sri Rabi Das to the effect that today on 08/09/21 at 19:35 hrs I received a specific source information that two persons is standing with one carton box containing huge quantity of contraband Cough Syrup at Sevoke Road in front of City Mall for disposing the same for their wrongful gain. The matter has been diarized at Panitanki TOP vide Panitanki TOP GDE No-203 dated 08/09/21. Accordingly, I informed the matter to OC Panitanki TOP as well as 5n Sudio Chakraborty, Inspector-in-Charge, Siliguri Police Station, SPC in writing a letter to him and expressed the entire information. Accordingly he directed me to work out the information immediately. Hence, at about 19:55 hrs as per his kind direction myself along with SI Rana information immediately. Then, as per source information, we approached towards Sevoke Road in front City Mall area & as per identification by source we managed to cordoned the place and found that one person was standing with a cycle loaded with one cartoon on the carrier of that cycle and another person helped him from back side to keep the cartoon safely on the cycle carrier. Accordingly we detained them. searched in presence of Executive Magistrate or any Gazetted Police Officer. They agreed to be searched by any one of them. Further, I served them option notice in accordance with provisions of law in this regard in writing and they also gave their approval of being searched by any one of them in writing on the notice served to him. Then I informed the matter to I.C.Siliguri PS & I requested him to come at Sevoke Road in front of City Mall area to remain present and supervise the search, seizure and label being a

Accordingly, at 20:35 hrs Sri Sudip Chakrabory, I. C. Siliguri PS arrived at the spot in uniform and Gazetted Police officer disclosed his identity to the detained person as well as to the witnesses as a Gazetted Police Officer. I also offered the independent witnesses and the accused persons to search our Police Party as per provision of law. But they refused to search the police party. Then under the supervision of Sri Sudip Chakraborty, Inspector in Charge of Siliguri Police Station, SPC and in presence of two independent and disinterested public witnesses, searched the detained both persons following all formalities keeping their decency but nothing could be recovered on his person except his wearing apparels. Then, I opened the carton box which was kept on the carrier of cycle and found that the above seizure articles kept concealed in the said carton box wrapped with plastic which is not visible from the outside. Then the detained persons confessed that they were carrying the box in concealed manner for selling/supplying to young boys at Punjabi Para/Vidya Chakra Colony and its adjacent area. On demand in presence of the Gazetted Police Officer, Sri Sudio Chakraborty, C. C. Siliguri PS, they failed to produce any valid document in support of possessing of the said contraband Cough Syrup which was holding by them.

Accordingly I counted the said Cartoon box containing Cough Syrup, which was found in the Joint possession of the above noted detained persons namely Sahadab Barman S/O Sudha Ranjan Barman and (2) Niranjan Das S/O Sri Rabi Das and found total 103 bottles of "Cefrex" Cough Syrup (Chlorpheniramine Maleate & Codeine Phosphate Syrup) containing 100 ml each marked as Exhibit- A, and also collected two bottles of said contraband Cough Syrup containing 100 ml each as sample taken from Exhibits A and marked as Exhibits A-1. Then, I seized the above noted articles under proper seizure list and labeled, duly signed by the above noted witnesses, Police personnel and the Gazetted Police Officer, Sri Sudip Chakraborty and duly acknowledge by the detained persons. I also supplied a copy of seizure list to the detained persons. The whole search, seizure & label were made in between 20:55 hrs and 21.35 hrs. On further asked the apprehended person confessed in presence of Gazetted Police Officer, Sri Sudip Chakraborty, I.C. Sillguri PS and other witnesses that they procured the said seized Cough Syrup from Darjeeling side for the purpose of illicit gain. On interrogation they disclosed that they had been dealing in such business of selling the said Cough Syrup illegally since long. Then I arrested the above noted both accused persons namely Sahadab Barman S/O Sudha Ranjan Barman and (2) Niranjan Das S/O Sri Rabi Das after observing all guidelines of Apex Court.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely Sahadab Barman S/O Sudha Ranjan Barman and (2) Niranjan Das S/O Sri Rabi Das.
