On Saturday 4, 2021, at around 12.15 PM, I was going to Lexican Motors, Khapsail More for the RC & Number plate. On the way to Medical More Mini Market, there was a small accident where my car had dent damage. ~~Boo~~ with a toto Guy. The nearby people asked him to wait near the Mor ~~Bo~~ that he and we could come to mutual understanding. But the boy ran away. We looked around but he was not there. So we headed to Tata showroom & gave over car in workshop. On Saturday eve, I got a call from workshop that I could take my car from them. I took a time of Monday 4:00 PM.

On Monday around 4:00 PM, me, brother & Father were walking to Medical More to take a toto to Khapsail More. The same guy was standing there with other toto guys. On seeing me, he recognised & started abusing me. I told him that \rightarrow why are you abusing me? I left you that day without asking any damage. He immediately got down from his toto and started intimidating me. He abused me first & I started abusing him back. He then came towards me to hit me. I pushed him. He charged again seeing which ~~boe~~ my father came in between & he held my father by his neck. The two fell down & I started shouting & pulling him by his hairs as he has ~~boe~~ his hand on my

father's mouth & nose. My brother came to my rescue and separated the two from the floor along with other people standing there. He got up & said something in his language and started washing his face. People nearby were saying 'What happened? Forget it. Now patch up & please dissolve the Matter'. I said I don't want damage but he is abusing me, charging me & hitting my father. I want an apology. Suddenly, a man called Chandan (Toto) came in & started intimidating my father. I told him he was hitting my father & we were helping them separate. He didn't want to talk to me & said 'Aap Ladli hai. Apse Nahin Baat Karunga'. I said 'incident happened with me. He then spoke to me and understood the matter & dissolved it. He asked the boy to apologize to my father & let go. It was around 4:40 PM. He apologized & we did the same & left. Now, at around 11:30 PM, they were calling us saying he is a police officer and asked to call a number which was of boy. His mother abused me (very profane language) & said she will finish us. Next day at around 2:15 PM & 4:00 PM

he called us from different numbers appearing someone be police officers and are calling me alone & an unknown place. Numbers they were calling from - 9126712676, 7586057888. They are always calling & intimidating me and my family & are speaking very obscene language with me.
