

Darjeeling, hereby informing you that I became the absolute and exclusive owner of land measuring 3.13 Acres, recorded in the Plots No.16, 45, 51 (Old) and 24, 56 (New) of Sheet No.10, Khatian No.41 (Old), 3887 (New) and said land is situated at Pargana - Baikunthapur, A.D.S.R. Office - Rajganj, Mouza - Binnaguri, P.S. New Jalpaiguri (the ten Bhaktinagar), J.L.
