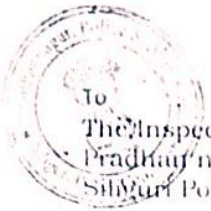

I, SI Khela Murmu of Pradhan Nagar Police Station under Siuliguri Police Commissionerate do here by lodge this written complaint to the effect that today i.e 10.09.2021 in between 13:05 hrs to 13:25 hrs . myself along with forces of Pradhan Nagar Police Station had been to Junction area, PS-Pradhan Nagar, Darjeeling and found the above noted persons were loitering and gathered without wearing mask. On asking the above noted persons stated before me that they were well aware of the pandemic situation and they supposed to wear mask. Hence, they violated the order promulgated by the Govt. of West Bengal for combating the spread of COVID- 19 vide order No 647-ISS/2M-22/2020 dated 15.05.2021 and Notification number 347 - 01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April , 2021.

Accordingly, I arrested them u/s 41 Cr.P.C in c/w the above noted matter. Hence, I request you kindly to start a specific case as per law against the above noted arrested persons and arranged for proper investigation of the case.
