Subject : General Diary

This is to inform you that on 10<sup>™</sup> September 2021 at around 11 am, we with my party friends were discussing about 159-Bhawanipur By-Election to be held on 30 September 2021, young boys gave me proposal to celebrate if Mamata Banerjee wins, on result date i.e. 03/10/2021. At Ashrafnagar More.

On 11th September at 10:30 pm, I with my friends were standing at Ashrafnagar More, it was raining heavily, all of a sudden a local miscreant alias "VEDA" surname unknown, resident of Iskcon Road, Siliguri. (Local BJP Cadre) got down from a 4-wheeler at Ashrafnagar more, complete intoxicated condition and engaged in unnecessary confrontation with us. He was not wearing a mask and forcefully trying to get into nose to nose verbal conflict without any reason abusing us for being supporters of TMC party. Finally we learnt that he had a political vendetta about the proposed celebration we had planned of Mamata Banerjee's win at our Locality. I was alone and did not uttered a word, I was shocked. He repeated the threats numerous times, gave serious warnings, unless a local man appeared on the scene and escorted me safely to home. I feel it is a well calculated political conspiracy with revenge attitude, as Ashrafnagar area Part 151, 152 is a full TMC majority area.

Sir, I'm in a complete mental shock and fear, I'm a lower middle class family man, father 84 year aged Alzheimer's Patient, mother bed ridden, 6 year old baby girl, and an ailing wife, patient of high pressure. I'm the only person to take care of my family & earning member. Today's incident had shattered my mental peace the activity of those hooligans and outrageous antisocial, seem an open "DADAGIRI" and any unfortunate incident the happens to me they will be solely responsible for the same.

Sir, I'm a victim of trauma, vandalism, political vendetta, and above all unprecedented "dadagiri" of hooligans.

Your immediate action his highly solicited, SOS and oblige.
