He disclosed his name as mentioned above. Then I seized the above noted illicit liquor and spirit under proper seizure list in presence witnesses and also labelled the same. The whole process of seizure and labelling was made in between 19:20 hrs to 19:35 hrs.

On interrogation, He admitted that he procured the liquor, spirit illegally and had been selling them illegally to the people. Thereafter, I arrested him u/s 41 Cr.P.C. by preparing a

proper memo of arrest in presence of witnesses.

I, therefore pray before your honour to take legal action as per law against the accused person namely Kanu Barman (31), S/O- Lt. Harkumar Barman of Koalabagan, PO+PS Matigara, Dist- Darjeeling under proper section of law.
