

In producing herewith one accused person namely (1) Mithu Chakraborty (38) S/O Lt. Dipak Chakraborty of neur Debidanga club, Champasari Ps.Pradhan Nagar ,Ps Pradhan Nagar,Dist-Darjeeling under arrest along with seizure list with following seized articles:-

(1) 800(eight hundred) pieces of light pink colour "Yaba" tablet in four (04)blue coloured transparent small plastic packet each packet contains 200 pieces of Yaba tablets from the right side pocket of accd. Michit Chakraborty, who was driving the scooty without any registration number marked as Exhibit-A, and 05 pieces of Yaba tablets from each packet total 20(twenty) pieces extracted as sample as Exhibit-A-1

 One blue colour scooty without any displayed registration number (naving engine no. E3Y4E0059583 & Chasiss no. ME1SED196H0098188).

I St. Haren Mohanta of Pradhan Nagar PS, SPC would like to lodge this written complaint against the above noted accused person who had been arrested for contravening the norms of NDPS Act to the effect that today on 15.09.21 at 18:25 hrs myself received a secret source information that one person coming in blue colour scooty from Bagdogra side and within a short period of time he will reached at Darjeeling more to deliver huge quantities of "Yaba" tablet which is "madness drug" (main substances that make up the drug are caffeine and methamphetamine, otherwise known as crysبوء meth to his designed customer, he could be caught red handed. Wasting no time I diarized the information to Pradhau. Nagar PS GDE NO- 936 Dated 15.09.21 and consequently informed the secrete input to you for kind instruction Subsequently on being directed, myself along with ,SI. Binup Mahato PSI.Chetan Dongal, ASI. Ratan Pradhan , CV/223 Swapan chettri and CV/242 Rakesh Mangar left PS along with investigating kits i.e, the weighing articles, envelope, gum, seal etc from Pradhan Nagar PS at 18:30 hrs for perusing the information by Govt. Vehicle bearing regd. no. WB 74 AC 9851. This refers to Pradhan Nagar PS GDE No- 937 Dated 15.09.21, under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. While going to near Darjeeling more under Pradhan Nagar Ps we stopped and contacted two person. namely (1)Munna Sha(29) S/O Dilip Sha of Bandri Jote, Dagapur, Ps. Pradhan Nagar/Djg ii)Rabi Ram (25) S/O Suresh Ram of Shivnagar, Ps. Pradhan Nagar/Djg and make them aware of the information in hand and requested them to act as witnesses if any search and seizure would be made necessary upon which they agreed and I gave them notice in this regard. Thereafter we along with the independent witnesses reached at Darjeeling more at 18:45 hrs.

On reaching there waited long and after a while one blue colour scooty was coming from Bagdogra side at about 22:35 hrs ,my source pointed the scooty. Accordingly we gave signal to stop the scooty but the scooty driver tried to ned away .However ,we apprehended the person with scooty. Thereafter we disclosed our identity and the information it hand and stated him that he will be searched in person for the purpose. The person was hesitating about the search .There was enough reason to believe that the article possessed contraband one. Subsequently on being asked he disclosed his identity as noted above and thereafter, I gave them the written option to be searched before a Magistrate or a Gazetical Officer upon which he agreed to be searched before a gazetted officer. Consequently I contacted with I/C Pradhanna and PS Sri Subhasish Chaki and stated him about the incident and requested him to be present at the spot as Gazatted officer for supervising search and seizure in presence of witnesses. Sri Subhasish Chaki, I/C PDN PS arrived at the spot at 22:45 hrs and thereafter the process of the search was conducted. Before conducting the search self search of mine and Sri Subhasish Chaki had been conducted by the witnesses. Subsequently on being searched total 4(four) blue colour transparent plastic packets each packet containing Yaba tablet total counting 800pieces . He stated that he has procured the said Yaba tablets from Malda side and sell the same in and around Siliguri area to obtain huge profit clandestinely. Thereafter I seized the recovered 800 pieces Yaba tablet and the Scooty under proper seizure list duly signed by the accused persons and witnesses. The seizure was made in between 22:50.hrs to 23:45.hrs. In the seizure list I obtained the signature of accused person, Sri Subhasish Chaki I/C Prdahannagar PS as gazatted officer, witnesses and put in the signature of accused person, Sri Subhasish Chaki I/C Prdahannagar PS as gazatted officer, witnesses and put in the signature of accused person. signature too. The mother packets have been labeled as "A" and took out 5 pieces of Yaba tablet from each packet total 20 pieces as samples from mother packet as sample packet marked as "A1". Consequently the apprehended person has been arrested issuing Arrest Memo for contravening the norms of NDPS Act and returned back to Pradhan Nagar Ps.

On the above circumstance, I pray before you for starting a specific case against the above noted accused person namely (1) Mithu Chakraborty(38) S/O Lt. Dipak Chakraborty of near Debidanga club, Champasari Ps.Pradhan Nagar,Ps Pradhan Nagar,Dist-Darjeeling, under proper section of law and arrange for its Investigation.
