I, Sri Nikhil Das, S/o Mridul Das of Sraban Nagar, Bagrakote, Near Radha Gobinda Mandir, P.S. Siliguri, Dist. Darjeeling, do hereby lodge this FIR against Sri Raju Baroi @ Bhogi Baroi, S/o Ranjit Baroi of Sraban Nagar, Bagrakot, Siliguri to the effect that today i.e. on 17/09/2021 at about 6:45 PM while my wife went to a grocery shop near Near Radha Gobinda Mandir, at that time the said Bhogi Baroi over some previous grudge attacked my wife with a knife and put the said knife over the throat of my wife, in order to kill her my wife tried to save her life and received severe bleeding injury on her left hand.

On hearing the hue & cry the local people gathered and they save the life of my wife. Subsequently she has been taken to Hospital and is now undergoing medical treatment with precarious condition.

I therefore request you please take immediate suitable legal action against the said Raju @ Bhogi Baroi and thus oblige thereby.
