Since the inception of my married life he has been torturing me but lately the torture has become unbearable. He has beaten me ruthlessly on 17/09/2021 and also stole all my money amounting to Rs. 50000/- and documents from my almirah by making a duplicate key of my almirah, after which I came down to Siliguri and got myself examined at Civil Hospital, Government of West Bengal. Such incident frequently takes place with me, but I kept quiet as to save my marriage. But now things have become more vulnerable and my life is at great risk.

I request you to interfere into the matter and take necessary steps and help me recover the necessary at the earliest
