Sir,

This is to inform you that, I, Smt. Parbati Sarkar Das, resident of Shantipara, Siliguri, is married to Sri Tapas Das Since 3 years. Since my marriage I have been working as household at Digha and my husband has been living at my means. Since the inception of my married life he has been torturing me but lately the torture has become unbearable. He has beaten me ruthlessly on 17/09/2021 and also stole all my money amounting to Rs. 50000/- and documents from my almirah by making a duplicate key of my almirah, after which I came down to Siliguri and got myself examined at Civil Hospital, Government of West Bengal. Such incident frequently takes place with me, but I kept quiet as to save my marriage. But now things have become more vulnerable and my life is at great risk.

I request you to interfere into the matter and take necessary steps and help me recover the necessary at the earliest
