Sub: Prayer to lodge an FIR due to theft of two-wheeler motorcycle from my rented house in Shivmandir

Respected Sir,

I Pintu Prasad Jaiswal, S/O Mr. Parashnath Prasad Jaiswal, a permanent resident of Sombaray Bazar, PO Fagu, Gorubathan, Dist Kalimpong-735231 presently staying in the house of Mr. Amar Saha, Sulagna Building, Indirapally, Shivmandir-734011, Dist Darjeeling would like to inform you that some miscreants broke into my house and stole my two-wheeler bike bearing WB 74AN 8771 which was a Yamaha FZ V2 bike in blue and black color (bought in November on Saturday midnight which I came to know when I woke up in the morning and went out to open the gate at around 7.30 am on Sunday, 12.09.2021).

I immediately informed my house owner and when we enquired through the area we found that the bike was stolen and taken away from the back gate of our house where the lock was open and thrown with the gate opened. Since, I had an NTA NEET Exam, 2021 Observer duty and was supposed to reach SF Road Canara Bank to collect the Trunk containing question booklets and other materials. I immediately called the landline number of Matigara Police Station and informed him regarding the burglary to which the concerned official asked my details and told me that the enquiry team will reach my place soon. I immediately told him that I have a NEET Exam Observer duty today and have to go for collecting the trunk and would like to request you to register my complaint to which he told me that I can go for my duty and do register an FIR the next day and make sure that the house owner remains there to narrate the entire details to the police officials.

Later during the day, the police officers visited the house twice on Sunday and enquired about the incident from the house owner as stated to me by the house owner.

Thus, I would like to lodge an FIR against the unknown miscreants and would like to request you to take appropriate action so that the burglar can be arrested and justice be served to me.
