Respected Sir/Madam,

I, SRI RAVI AGARWAL resident of Station Feeder Road, Siliguri Dist Darjeeling am Director of M/S ASHA ISPAT PRIVATE LIMITED, a private limited company, having its registered office at Station Feeder Road, Siliguri, Dist Darjeeling with its factory at Khaprail Road, P.O. & P.S. Matigara in the District of Darjeeling – 734010 would like to lodge a written complaint stating as follows:

1. That KAILASH CHANDRA @ KAILASH CHOUDHARY, S/o Dhanna Ram is the manager of the a factory owned by M/S ASHA ISPAT PRIVATE LIMITED that deals in manufacturing of iron and steel TMT rods for past 12 years and He reside in a quarter which is situated inside the factory premises.
2. That on 17th September, 2021 around 09:30 p.m., one Gulten (alias Manik Rai), S/o Not known along with two of his sons, namely Ujjwal Rai & Surjoo Rai and his associates Ram Barman @ Mathu, S/o Not known, all are residents of Gawal Jote, 6th Mile, Nema, P.O. & P.S. Matigara in the District of Darjeeling along with 6 to 7 other unknown person entered into the factory premises by crossing over the concrete boundary wall.
3. That thereafter the said miscreants broke the asbestos sheet of the roof and tore apart the false ceiling and jumped inside the room in the factory. On hearing the sound Kailash Chandra was shocked and became alert and seeing the miscreants he tried to stop them but they were carrying rods, swords and knife. Seeing this weapon he became startled.
4. That then one of The miscreant then pushed Kailash Chandra hard and he fell into the ground. They then kicked him in his abdomen and struck hard on the head. He felt dizzy and things started appearing blurred. One of the said person then hit him hard with rod.

5. That about 30 minutes later, Kailash Chandra ^{SILIGURI} saw them walking away. While leaving they took all my belongings which was inside the room which included cash amounting to Rs. 28,000/- (Rupees Twenty Eight Thousand). They also vandalised and destroyed few of the things in the room.
6. Thereafter, Kailash Chandra somehow managed to call me (director of factory) and after sometime one of the employee in the company, namely Sri Amit Barman, came to the factory who somehow managed to take Kailash Chandra to nearby hospital at Neotia Getwel Healthcare Centre at Matigara.
7. That Kailash Chandra was immediately attended there and the doctor in charge gave me First aid and he had to get several stitches on his forehead. He is still in fear and having bodily pain which is unbearable.
8. That the said miscreants are dacoits and do not hesitate to take law in their own hands. Moreover they are a threat to society and may hurt innocent people to fulfill their motive.

In the above circumstances, I would like to request you to kindly take immediate and necessary action against the aforesaid persons and oblige.
