In producing herewith one male accused person namely Nantu Roy(55yrs.),S/O Lt. Ram Ch.Roy Natun Para near Ramghat Bridge,W/NO-05,PS-Siliguri,Dist - Darjeeling along with the following seized articles as per proper seizer list.

1.13(Thirteen) bottles of Himalaya Gold 60up premium country spirit (each bottles containing 600ml. & MRP Rs 100/-)

I ASI Sanjay Hasda of Khalpara TOP under Siliguri Police Commissionerate lodge a written complaint against the above noted person to the effect that on 18.09.2021 at 14:25 hrs. received an information from Natun Para near Ramghat Bridge,W/NO-05,PS-Siliguri,Dist-Darjeeling that one person has gathered huge quantity of illegal liquor which kept in his house which was kept in one gunny bag for selling the same in the open market for his wrong full gain. Diarized the fact in GD vide Khalpara TOP GDE NO -623/21, Dated-18.09.2021. As per your kind instruction myself along with ASI Samiran Das, C/1072 Anand Thakuri CVF-980 Ranjan Ojha and proceeded to the PO to work out the information. At 14:35 hrs. we reached at the Natun Para near Ramghat Bridge,W/NO-05 ,sometimes after being identified by the source our police party held raid and recovered the above noted articles from the possession of above referred person. On demand he could not produced any valid license/documents in support of said liquor. he become nervous and admitted his guilt before us and stated that he sell same in open marked for his wrong full gain. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizer list and level and took signature of the accused person one bottles taken as sample. (The seizure was made in between 14:40hrs. to 15:25hrs.) I arrested the accused person U/S 41 Cr. P.C and issued Memo of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Nantu Roy(55yrs.), S/O Lt. Ram Ch.Roy Natun Para near Ramghat Bridge,W/NO-05,PS-Siliguri,Dist - Darjeeling under proper section of law and arrange for investigation.
