
Most respectfully, I, P.S.I. Chetan Dangal of Pradhan Nagar P.S / SPC would like to submit the written complaint before you that on yesterday night i.e. on 17.09.2021 in course of special Plain Cloth duty myself along with ASI Ashit Singha, CV/646 Baban Das, CV/645 Pankaj Gupta, CV/223 Swapan chettri and CV/242 Rakesh Mangar was performing raid against roadside rowdies and illegal activities under Pradhan Nagar P.S area on the occasion of Shree Shree Biswakarma Puja vide PDN Ps GDE No. 1060. At about 22.00 hrs we reached near Sharda Hotel, under Pradhan Nagar PS/SPC, and saw that there was a quarrel going on between 7-8 persons, we stop there and asked those persons not to create any nuisance, but they did not pay any heed to us and started calling their gangs. After sometimes approx 15-20 persons came to the spot in bikes with deadly weapons like Lathi, rod, Hockey stick ,bamboo sticks and start hitting one another, in that chaos many people got injured. Then I Informed the situation to I/C Pradhan Nagar P.S and duty officer to send re-enforcement team to managed the situation. Thereafter immediately re-enforcement team came to the spot and charge to apprehend those miscreants to control the untoward Incident, and managed to apprehend 01 (one) person namely Ranjan Sahani of Ratanlal bunti, Mallaguri, under P.S Pradhan Nagar and other 20/25 miscreants managed to flee away leaving two motor cycle Reg.no. WB74BE/8724 &WB74BG/5439 , one Iron rod, Bamboo one stick in the spot. Accordingly, I have seized both motor cycles ,Iron rod, Bamboo stick under proper seizure list duly signed by witness.

Under the above circumstances, I pray before your good self to take legal action against said Ranjan Sahani of Ratanlal bunti, Mallaguri, under P.S Pradhan Nagar, Dist- Darjeeling and others 20/25 miscreants for using criminal force and creating riot, disturbing public peace and tranquility.
