Respected Sir,

I Sri Bijay Kumar Ray (Mob: 9832388994) son of Latelige and CRay, resident of Gurung Basti, Near- Model High School, Ward No. III of S.M.C., P.O. & P.S. Pradhan Nagar, Siliguri, Dist. Darjeeling, would like to inform you the following facts:-

1. That on 17.09.2021 at about 10.00 P.M. to 10.30 P.M. my cousin brothers namely (i) Shankar Ray (ii) Bishnu Ray both are son of Late Uttam Ray and my own brother namely Bhutan Ray @ Raj Kumar Ray son of Late Badri Ray all are resident of Gurung Basti, Near- Model High School, Ward No. III of S.M.C., P.O. & P.S. Pradhan Nagar, Siliguri, Dist. Darjeeling, one of my Cousin brother namely Shankar Ray son of Late Uttam Ray phoned me that some persons namely (i) Uday Singh son of Sri Manoj Singh of Mallaguri, Near- Pyasi Hotel, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling,(ii) Sujit Ray (Yadav), (iii) Sanjay Ray(Yadav) both are son of Sri Jagadip Ray (Yadav) of Mallaguri, Opposite- Hanuman Mandir, Near- Deepu Garage, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, (iv) Jagadip Ray (Yadav) son of Unkonwn of Mallaguri, Beside- Hanuman Mandir, Near- Deepu Garage, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, (v) Hulash Ray son of Unknown of Mallaguri, Opposite- Hanuman Mandir, Near- Deepu Garage, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, (vi) Anil Ray, (vii) Ajay Ray, (viii) Arjun Ray all are son of Hulash Ray of Mallaguri, Opposite- Hanuman Mandir, Near-Deepu Garage, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling and 12 to 15 their associates are threatened, physically assaulted and brutally attacked with fists and blows and by bamboo Bans, lathi, battam, Iron rod, nukes, and also leather belt at in front of the Petrol Pump, Near- Sarda Hotel, Mallaguri, P.O. P.S. Pradhan Nagar, Dist. Darjeeling.

After that on that time I went to the incident I saw my own brother and my cousin brothers were lying down here and there on the earth with Byoy Erman Ray

whole body blooded after that I tried to save them from their hands and then they also physically assaulted me anyhow I took them in the car and admit to the Siliguri District Hospital, Siliguri, Dist. Darjeeling.

2. That my own brother and my cousin brothers were get serious injury on their heads, lips and legs, one of my cousin brother namely Shankar Ray got 18 to 20 stitches on his head, 5 to 6 stitches in right eyebrow and whole body swelling, Bisnu Roy got 8 to 10 stitches on his head, 4 stitches in his lips, 4 stitches in right hand middle finger, 2 teeth broken of upper jaw, 6 stitches in left leg and whole body swelling and my own brother namely Bhutan Ray @ Raj Kumar Ray got 4 stitches on his head and whole body swelling now they all are got very serious injury.

It is pertinent to mention here that one motor bike registered owner Sri Bishnu Roy son of Late Uttam Ray of Gurung Basti, Near- Model High School, Ward No. III of S.M.C., P.O. & P.S. Pradhan Nagar, Siliguri, Dist. Darjeeling, vide registration No. WB-74BE-8724 (Royal Enfield bullet 350 c.c) were also affected by them and seized by Pradhan Nagar P.S. and One Mobile Phone (Realme7 white colour) vide IMEI No. 868696059807574/66, MDN No.9002630887/6005740799 and Rs. 8,000/-(Rupees Eight Thousand) also snatched by the above said culprits.

- 3. That due to such assault upon me and my aforesaid brothers and due to their such attempt to murder of my said brothers in such cruel manners, they sustained severe injuries on their persons and they were medically treated at Siliguri District Hospital, Siliguri, Dist. Darjeeling on 17.09.2021 at about 11.00 P.M. to 11.30 P.M. and still they are under medical treatment.
- 4. That on 18.09.2021 at about 1.30 P.M. (After noon) I discharged my own risk my aforesaid brothers from the Siliguri District Hospital, Siliguri, and now admitted to Mukherjee Hospital, Near- Meghdoot Cinema Hall, P.O. & P.S. Siliguri, Dist. Darjeeling and they all are in I.C.U. ward for better treatment.
- That due to serious injury caused due to such assaulted by them upon my aforesaid brothers and me delay is caused for lodging this F.I.R. which may kindly be condoned.

6. That the Xerox copies of medical treatments papers are enclosed here with.

I therefore request you to kindly take necessary steps against the aforesaid culprits for the commission of the aforesaid offences upon my aforesaid brothers and me.
