I, Mumtaz Khatun, Wife of Abdullah Hasib, D/o Md. at Khaprail, P.O. New Chamta & P.S. Matigara, Ibrahim, Residing District Darjeeling inform you that I got married on 25/05/2008 with Abdullah Sahib S/o Late Adil Hasid, Resident of Chamurchi Bazar, P.W.D, P.O. & P.S- Banarhat, District- Jalpaiguri. at Vill- Baribalia, District- Begusarai, in the State of Bihar and thereafter I was taken by my husband to his abovementioned address and we started to live as husband and Wife and out of our wedlock there are three children. That at the time of the said marriage, my father gave cash of a sum Rs. 1,00,000 (Rupees one lakh) only to the my husband as per his demands along with gold ornaments, furniture, utensils, clothes etc. That at the initial stage of their matrimonial life the things were quite normal but after elapse of few months I noticed and was fully surprised that my husband is a man of bad temperament and he had no interest in matrimonial life. After few months he frequently started picking up quarrels with the me on flimsy grounds/pleas and also abused me with most filthy languages on trifling issues. In spite of the said behavior of the my husband, I tried to adjust with my husband to keep peace in the matrimonial home and also with a hope that by lapse of time, the acts, conducts and the behavior of the my husband would be changed. My husband always used to demand money from me and whenever I denied he would start using filthy languages and pressurized me to meet his monetary demands from my parents. He started to use slang languages and used to ask me to take money from my parents to fulfill his demand of dowry. I had also found that my husband has no interest in my issues and his attitude regarding all the matters relating to me was doubtful and whenever I asked the my husband to keep good behavior/
relationship, then the my husband started assaulting the me inhumanly
and to beat me brutally. That just after gap of few months in the year
2009 when the I was pregnant then also my husband again started
mental and physical tortures upon me and even my husband started
denying providing food, clothes etc knowingly that the I was a housewife
and fully dependant on him for any basic needs and in a condition like
pregnancy healthy food and nutrition is very much required. That even
during the time of my illness he had bitten me with fists and blows.
Thereafter I decided to complain against him but somehow my husband
by convincing emotionally managed me not to file any complain against
him.

Unfortunately, just after few months again my husband started assaulting the me frequently in an inhuman manner, on many occasions physically assaulted me with fist and blows as well as scratches. The degree of such assault and torture crossed the limit on 24th December, 2020, when the my husband tried to kill the me by pressing my throat, but somehow the I had managed to save myself from the evil clutches of my husband and finding no other alternative thus and to save my life and I along with my children have compelled to take shelter at my parent's house, and since then, I am residing there and passing my days with the beg help of my family members.

Sir, even after the all mental and physical torture and abovementioned incident I to save her matrimonial life with an intention to give a chance and if my husband regret, I since January 2020 called my husband, but he had not responded any point of time. On 20/09/2021 when the I called my husband, he threatened me that he has no interest in me and in his children and if the I will raise voice against him then I shall have to face dangerous consequences and even he will not hesitate to kill her.

Sir, my husband is very dangerous person and always committed mental and physical cruelty upon me for dowry. So I am requesting you to take necessary action against my husband.
