Sir,

In producing herewith one accused person namely Raju Singh Biswakarma-47yrs s/o Lt Gokul Singh Biswakarma of Durganagar, Near Sona Memorial School, PS Bhaktinagar Dist Jalpaiguri along with the following seized articles as per proper seizure list:

1. 10 (Ten) no's of pet Bottles of Himalayan Gold 60up country spirit (each bottle containing 600 ML)
2. 10 (Ten) no's of pet Bottles of Himalayan Gold 60up country spirit (each bottle containing 300 ML)
3. 12 (Twelve) pouch packets of Officers Choice strong whisky each packet containing 180 ML which was packed in one big nylon bag.

I beg to report that I, SI Prakash Saha of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one Raju Singh Biswakarma-47yrs s/o Lt Gokul Singh Biswakarma of Durganagar, Near Sona Memorial School, PS Bhaktinagar Dist Jalpaiguri to the effect that on 24.09.21 at 14.35 hrs received a source information from Don Bosco More, Sevoke road under Bhaktinagar PS that one person namely Raju Singh was waiting near Don Bosco More to go to Safugara with huge quantity of liquor for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-1221 dated 24.09.21. As per your kind instruction myself along with force proceeded to the PO to work out the information. At 15.05 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities. (The seizure was made in between 15.30hrs to 16.10hrs)

I therefore request you a specific case may kindly be started against the accused person namely Raju Singh Biswakarma-47yrs s/o Lt Gokul Singh Biswakarma of Durganagar, Near Sona Memorial School, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
