Sir,

In producing herewith one arrested accused person namely Mahadeb Sharma(59) s/o late Bishnudeb Sharma of Tiranga more, Shastrinagar, Ward No.41, PS Bhaktinagar, Dist. Jalpaiguri along with the following seized articles as per proper seizure list:

1. Twenty (20) Bottles of Pet Bottles of Galaxy boss 60 UP Country Spirit (each bottle containing 300 ml.).
2. Four (04) Bottles of Mc Dowell's No.1 celebration Mature XXX RUM (each bottle containing 180 ml.).
3. Twelve (12) Bottles of TUBORG PREMIUM BEER STRONG (each bottle containing 650 ml.)

I, PSI Sailesh Subba of Bhaktinagar PS, SPC would like to lodged a written complainant against the above noted arrested accused person to the effect that on 25.09.2021 at 14.50 Hrs received a source information that one Mahadeb Sharma(59) s/o late Bishnudeb Sharma of Tiranga more, Shastrinagar, Ward No.41, PS Bhaktinagar, Dist. Jalpaiguri have gathered huge amount of liquor illegally in his house for selling the same to the customer for his wrongful gain. This refers to Bhaktinagar PS GDE No-1294 Dated 25.09.2021. Accordingly, I informed I/C Bhaktinagar PS/SPC about the information. As per his kind instruction, I along with ASI rabin Lama C/374 Debraj Biswas,CVF/ 619 Dharmendra Roy, headed towards Shastrinagar to work out the information. At 15.10 hrs we reached at the spot, and after being identified by the source I along with force held raid at the house of Mahadeb Sharma and recovered the above noted seized articles. On demand he could not produce any valid license/documents in support of said liquor. During interrogation he admitted his guilt before us and stated that he has been selling the same to local people since long for his wrongful gain. I then prepared seizure list of the above noted articles in presence of witnesses namely C/374 Debraj Biswas,CVF/ 619 Dharmendra Roy both of Bhaktinagar PS/SPC undersigned of seizure list. The seizure was made between 15.25 hrs to 15.50 hrs. I arrested the said accused person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you to register a specific case may kindly be started against the accused person namely Mahadeb Sharma(59) s/o late Bishnudeb Sharma of Tiranga more, Shastrinagar, Ward No.41, PS Bhaktinagar, Dist. Jalpaiguri under proper section of law.
